Mr. DERRICK, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4907) to reform the concept of baseline budgeting.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4907) to reform the concept of base-
6 line budgeting. The first reading of the bill shall be dis-
7 pensed with. All points of order against consideration of
8 the bill are waived. General debate shall be confined to

1 the bill and the amendments made in order by this resolu-
2 tion and shall not exceed one hour, with thirty minutes
3 equally divided and controlled by the chairman and rank-
4 ing minority member of the Committee on Rules and thir-
5 ty minutes equally divided and controlled by the chairman
6 and ranking minority member of the Committee on Gov-
7 ernment Operations. After general debate the bill shall be
8 considered for amendment under the five-minute rule. It
9 shall be in order to consider as an original bill for the
10 purpose of amendment under the five-minute rule the
11 amendment in the nature of a substitute recommended by
12 the Committee on Rules now printed in the bill. The com-
13 mittee amendment in the nature of a substitute shall be
14 considered as read. No other amendment shall be in order
15 except those printed in the report of the Committee on
16 Rules accompanying this resolution. Each amendment
17 may be offered only in the order printed, may be offered
18 only by a Member designated in the report, shall be con-
19 sidered as read, shall be debatable for the time specified
20 in the report equally divided and controlled by the pro-
21 ponent and an opponent, and shall not be subject to
22 amendment. All points of order against the amendments
23 printed in the report are waived. If more than one of the
24 amendments printed in the report is adopted, only the last
25 to be adopted shall be considered as finally adopted and

1 reported to the House. At the conclusion of consideration
2 of the bill for amendment the Committee shall rise and
3 report the bill to the House with such amendment as may
4 have been finally adopted. Any Member may demand a
5 separate vote in the House on any amendment adopted
6 in the Committee of the Whole to the bill or to the commit-
7 tee amendment in the nature of a substitute. The previous
8 question shall be considered as ordered on the bill and any
9 amendment thereto to final passage without intervening
10 motion except one motion to recommit with or without
11 instructions.
