Mr. MOAKLEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Establishing the Select Committee on Narcotics Abuse and Control, the Select Committee on Aging, the Select Committee on Hunger, and the Select Committee on Children, Youth, and Families.

1 *Resolved,*

1 **SECTION 1. ESTABLISHMENT OF THE SELECT COMMITTEE**
2 **ON NARCOTICS ABUSE AND CONTROL, THE**
3 **SELECT COMMITTEE ON AGING, THE SELECT**
4 **COMMITTEE ON HUNGER, AND THE SELECT**
5 **COMMITTEE ON CHILDREN, YOUTH, AND**
6 **FAMILIES.**

7 Effective through December 31, 1993, there are here-
8 by established in the House of Representatives four select
9 committees, as follows: (1) the Select Committee on Nar-
10 cotics Abuse and Control, (2) the Select Committee on
11 Aging, (3) the Select Committee on Hunger, and (4) the
12 Select Committee on Children, Youth, and Families, of
13 which the functions, appointments and membership, au-
14 thority and procedures, administrative provisions, and
15 records and reports shall be as set forth in this resolution.

16 **SEC. 2. FUNCTIONS.**

17 (a) The Select Committee on Narcotics Abuse and
18 Control shall not have legislative jurisdiction. The select
19 committee shall have authority—

20 (1) to conduct a continuing oversight and re-
21 view of the problems of narcotics, drug, and
22 polydrug abuse and control, including (but not lim-
23 ited to) the study and review of (A) the abuse and
24 control of opium and its derivatives, other narcotic
25 drugs, psychotropics, and other controlled sub-
26 stances, as defined in the Comprehensive Drug

1 Abuse Prevention and Control Act of 1970, and any
2 such drug or substance when used in combination
3 with any other substance; (B) domestic and inter-
4 national trafficking, manufacturing, and distribu-
5 tion; (C) treatment, prevention, and rehabilitation;
6 (D) narcotics-related violations of the Internal Reve-
7 nue Code of 1986; (E) international treaties and
8 agreements relating to the control of narcotics and
9 drug abuse; (F) the role of organized crime in nar-
10 cotics and drug abuse; (G) problems of narcotics and
11 drug abuse and control in the Armed Forces of the
12 United States; (H) problems of narcotics and drug
13 abuse and control in industry; and (I) the approach
14 of the criminal justice system with respect to narcot-
15 ics and drug law violations and crimes related to
16 drug abuse;

17 (2) to review any recommendations made by the
18 President, or by any department or agency of the ex-
19 ecutive branch of the Federal Government, relating
20 to programs or policies affecting narcotics or drug
21 abuse or control; and

22 (3) to recommend to the appropriate commit-
23 tees of the House legislation or other action the se-
24 lect committee considers necessary with respect to

1 programs or policies affecting narcotics or drug
2 abuse or control.

3 (b) The Select Committee on Aging shall not have
4 legislative jurisdiction. The select committee shall have au-
5 thority—

6 (1) to conduct a continuing comprehensive
7 study and review of the problems of the older Amer-
8 ican, including but not limited to income mainte-
9 nance, housing, health (including medical research),
10 welfare, employment, education, recreation, and par-
11 ticipation in family and community life as self-
12 respecting citizens;

13 (2) to study the use of all practicable means
14 and methods of encouraging the development of pub-
15 lic and private programs and policies which will as-
16 sist the older American in taking a full part in na-
17 tional life and which will encourage the utilization of
18 the knowledge, skills, special aptitudes, and abilities
19 of older Americans to contribute to a better quality
20 of life for all Americans;

21 (3) to develop policies that would encourage the
22 coordination of both governmental and private pro-
23 grams designed to deal with problems of aging; and

24 (4) to review any recommendations made by the
25 President or by the White House Conference on

1 Aging relating to programs or policies affecting older
2 Americans.

3 (c) The Select Committee on Hunger shall not have
4 legislative jurisdiction. The select committee shall have au-
5 thority—

6 (1) to conduct a continuing comprehensive
7 study and review of the problems of hunger and mal-
8 nutrition, including but not limited to, those issues
9 addressed in the reports of the Presidential Commis-
10 sion on World Hunger and the Independent Com-
11 mission on International Development Issues, which
12 issues include—

13 (A) the United States development and
14 economic assistance program and the executive
15 branch structure responsible for administering
16 the program;

17 (B) world food security;

18 (C) trade relations between the United
19 States and less developed countries;

20 (D) food production and distribution;

21 (E) corporate and agribusiness efforts to
22 further international development;

23 (F) policies of multilateral development
24 banks and international development institu-
25 tions; and

1 (G) food assistance programs in the United
2 States;

3 (2) to review any recommendations made by the
4 President, or by any department or agency of the ex-
5 ecutive branch of the Federal Government, relating
6 to programs or policies affecting hunger or malnutri-
7 tion; and

8 (3) to recommend to the appropriate commit-
9 tees of the House legislation or other action the se-
10 lect committee considers necessary with respect to
11 programs or policies affecting hunger or malnutri-
12 tion.

13 Nothing contained in this resolution shall be construed to
14 limit or alter the legislative and oversight jurisdiction of
15 any standing committee of the House under rule X of the
16 Rules of the House of Representatives.

17 (d) The Select Committee on Children, Youth, and
18 Families shall not have legislative jurisdiction. The select
19 committee shall have authority—

20 (1) to conduct a continuing comprehensive
21 study and review of the problems of children, youth,
22 and families, including but not limited to income
23 maintenance, health (including medical and child de-
24 velopment research), nutrition, education, welfare,
25 employment, and recreation;

1 (2) to study the use of all practical means and
2 methods of encouraging the development of public
3 and private programs and policies which will assist
4 American children and youth in taking a full part in
5 national life and becoming productive citizens; and

6 (3) to develop policies that would encourage the
7 coordination of both governmental and private pro-
8 grams designed to address the problems of childhood
9 and adolescence.

10 Nothing contained in this resolution shall be construed to
11 limit or alter the legislative and oversight jurisdiction of
12 any standing committee of the House under rule X of the
13 Rules of the House of Representatives.

14 **SEC. 3. APPOINTMENTS AND MEMBERSHIP.**

15 (a)(1) The Select Committee on Narcotics Abuse and
16 Control shall be composed of not more than thirty-five
17 Members of the House, who shall be appointed by the
18 Speaker, one of whom he shall designate as chairman. At
19 least one member of the select committee shall be chosen
20 from each of the following committees of the House: The
21 Committee on Agriculture, the Committee on Armed Serv-
22 ices, the Committee on Government Operations, the Com-
23 mittee on Foreign Affairs, the Committee on Energy and
24 Commerce, the Committee on the Judiciary, the Commit-
25 tee on Merchant Marine and Fisheries, the Committee on

1 Veterans' Affairs, and the Committee on Ways and
2 Means.

3 (2) Any vacancy occurring in the membership of the
4 select committee shall be filled in the same manner in
5 which the original appointment was made.

6 (3) For purposes of this subsection, the term "Mem-
7 bers" shall include any Representative in, or Delegate or
8 Resident Commissioner to, the House of Representatives.

9 (b)(1) The Select Committee on Aging shall be com-
10 posed of not more than 67 Members, who shall be ap-
11 pointed by the Speaker, one of whom he shall designate
12 as chairman.

13 (2) Any vacancy occurring in the membership of the
14 select committee shall be filled in the same manner in
15 which the original appointment was made.

16 (3) For purposes of this subsection, the term "Mem-
17 bers" shall include any Representative in, or Delegate or
18 Resident Commissioner to, the House of Representatives.

19 (c)(1) The Select Committee on Hunger shall be com-
20 posed of not more than 33 Members of the House, who
21 shall be appointed by the Speaker, one of whom he shall
22 designate as chairman.

23 (2) Any vacancy occurring in the membership of the
24 select committee shall be filled in the same manner in
25 which the original appointment was made.

1 (3) For purposes of this subsection, the term “Mem-
2 bers” shall include any Representative in, or Delegate or
3 Resident Commissioner to, the House of Representatives.

4 (d)(1) The Select Committee on Children, Youth, and
5 Families shall be composed of not more than 36 Members
6 of the House, who shall be appointed by the Speaker, and
7 one of whom he shall designate as chairman.

8 (2) Any vacancy occurring in the membership of the
9 select committee shall be filled in the same manner in
10 which the original appointment was made.

11 (3) For purposes of this subsection, the term “Mem-
12 bers” shall include any Representative in, or Delegate or
13 Resident Commissioner to, the House of Representatives.

14 **SEC. 4. AUTHORITY AND PROCEDURES.**

15 (a)(1) For the purpose of carrying out its responsibil-
16 ities under this resolution, the Select Committee on Nar-
17 cotics Abuse and Control is authorized to sit and act dur-
18 ing the present Congress at such times and places within
19 the United States, including any Commonwealth or pos-
20 session thereof, or elsewhere, whether the House is in ses-
21 sion, has recessed, or has adjourned, and to hold such
22 hearings as it deems necessary.

23 (2) The provisions of clauses 1, 2, and 3 of rule XI
24 of the Rules of the House of Representatives shall apply
25 to the select committee.

1 (b)(1) For the purpose of carrying out its responsibil-
2 ities under this resolution, the Select Committee on Aging
3 is authorized to sit and act during the present Congress
4 at such times and places within the United States, includ-
5 ing any Commonwealth or possession thereof, or else-
6 where, whether the House is in session, has recessed, or
7 has adjourned, and to hold such hearings as it deems nec-
8 essary.

9 (2) The provisions of clauses 1, 2, and 3 of rule XI
10 of the Rules of the House of Representatives shall apply
11 to the select committee.

12 (c)(1) For purposes of carrying out its responsibilities
13 under this resolution, the Select Committee on Hunger is
14 authorized to sit and act during the present Congress at
15 such times and places within the United States, including
16 any Commonwealth or possession thereof, or elsewhere,
17 whether the House is in session, has recessed, or has ad-
18 journed, and to hold such hearings as it deems necessary.

19 (2) The provisions of clauses 1, 2, and 3 of rule XI
20 of the Rules of the House of Representatives shall apply
21 to the select committee except the provisions of clause
22 2(m)(1)(B) of rule XI relating to subpoena power.

23 (3) Nothing contained in paragraph (1) of this sub-
24 section shall be construed to limit the applicability of

1 clause 2(i) of rule XI of the Rules of the House of Rep-
2 resentatives to the select committee.

3 (d)(1) For the purpose of carrying out its responsibil-
4 ities under this resolution, the Select Committee on Chil-
5 dren, Youth, and Families is authorized to sit and act dur-
6 ing the present Congress at such times and places within
7 the United States, including any Commonwealth or pos-
8 session thereof, or elsewhere, whether the House is in ses-
9 sion, has recessed, or has adjourned, and to hold such
10 hearings as it deems necessary.

11 (2) The provisions of clauses 1, 2, and 3 of rule XI
12 of the Rules of the House of Representatives shall apply
13 to the select committee.

14 (3) Nothing contained in paragraph (1) of this sub-
15 section shall be construed to limit the applicability of
16 clause 2(i) of rule XI of the Rules of the House of Rep-
17 resentatives to the select committee.

18 **SEC. 5. ADMINISTRATIVE PROVISIONS.**

19 (a)(1) Subject to the adoption of expense resolutions
20 as required by clause 5 of rule XI of the Rules of the
21 House of Representatives, the Select Committee on Nar-
22 cotics Abuse and Control may incur expenses in connec-
23 tion with its duties under this resolution.

24 (2) In carrying out its functions under this resolu-
25 tion, the select committee is authorized—

1 (A) to appoint, either on a permanent basis or
2 as experts or consultants, such staff as the select
3 committee considers necessary;

4 (B) to prescribe the duties and responsibilities
5 of such staff;

6 (C) to fix the compensation of such staff at a
7 single per annum gross rate as provided by clause
8 6(c) of rule XI of the Rules of the House of Rep-
9 resentatives;

10 (D) to terminate the employment of any such
11 staff as the select committee considers appropriate;
12 and

13 (E) to reimburse members of the select commit-
14 tee and of its staff for travel, subsistence, and other
15 necessary expenses incurred by them in the perform-
16 ance of their duties and responsibilities for the select
17 committee, other than expenses in connection with
18 any meeting of the select committee held in the Dis-
19 trict of Columbia.

20 (b)(1) Subject to the adoption of expense resolutions
21 as required by clause 5 of rule XI of the Rules of the
22 House of Representatives, the Select Committee on Aging
23 may incur expenses in connection with its duties under
24 this resolution.

1 (2) In carrying out its functions under this resolu-
2 tion, the select committee is authorized—

3 (A) to appoint, either on a permanent basis or
4 as experts or consultants, such staff as the select
5 committee considers necessary;

6 (B) to prescribe the duties and responsibilities
7 of such staff;

8 (C) to fix the compensation of such staff at a
9 single per annum gross rate as provided by clause
10 6(c) of rule XI of the Rules of the House of Rep-
11 resentatives;

12 (D) to terminate the employment of any such
13 staff as the select committee considers appropriate;
14 and

15 (E) to reimburse members of the select commit-
16 tee and of its staff for travel, subsistence, and other
17 necessary expenses incurred by them in the perform-
18 ance of their duties and responsibilities for the select
19 committee, other than expenses in connection with
20 any meeting of the select committee held in the Dis-
21 trict of Columbia.

22 (c)(1) Subject to the adoption of expense resolutions
23 as required by clause 5 of rule XI of the Rules of the
24 House of Representatives, the Select Committee on Hun-

1 ger may incur expenses in connection with its duties under
2 this resolution.

3 (2) In carrying out its functions under this resolu-
4 tion, the select committee is authorized—

5 (A) to appoint, either on a permanent basis or
6 as experts or consultants, such staff as the select
7 committee considers necessary;

8 (B) to utilize the services of the staffs of those
9 committees of the House from which Members have
10 been selected for membership on the select commit-
11 tee;

12 (C) to prescribe the duties and responsibilities
13 of such staff;

14 (D) to fix the compensation of such staff at a
15 single per annum gross rate as provided by clause
16 6(c) of rule XI of the Rules of the House of Rep-
17 resentatives;

18 (E) to terminate the employment of any such
19 staff as the select committee considers appropriate;
20 and

21 (F) to reimburse members of the select commit-
22 tee and of its staff for travel, subsistence, and other
23 necessary expenses incurred by them in the perform-
24 ance of their duties and responsibilities for the select
25 committee, other than expenses in connection with

1 any meeting of the select committee held in the Dis-
2 trict of Columbia.

3 (d)(1) Subject to the adoption of expense resolutions
4 as required by clause 5 of rule XI of the Rules of the
5 House of Representatives, the Select Committee on Chil-
6 dren, Youth, and Families may incur expenses in connec-
7 tion with its duties under this resolution.

8 (2) In carrying out its functions under this resolu-
9 tion, the select committee is authorized—

10 (A) to appoint, either on a permanent basis or
11 as experts or consultants, such staff as the select
12 committee considers necessary;

13 (B) to utilize the services of the staffs of those
14 committees of the House from which Members have

1 (F) to reimburse members of the select commit-
2 tee and of its staff for travel, subsistence, and other
3 necessary expenses incurred by them in the perform-
4 ance of their duties and responsibilities for the select
5 committee, other than expenses in connection with
6 any meeting of the select committee held in the Dis-
7 trict of Columbia.

8 **SEC. 6. REPORTS AND RECORDS.**

9 (a)(1) The Select Committee on Narcotics Abuse and
10 Control shall report to the House with respect to the re-
11 sults of any field investigation or inspection it conducts.

12 (2) The select committee shall submit an annual re-
13 port to the House which shall include a summary of the
14 activities of the select committee during the calendar year
15 to which the report applies.

16 (3) The select committee shall report to the House
17 its recommendations for a comprehensive program to con-
18 trol the worldwide program of drug abuse and drug traf-
19 ficking.

20 (4) Any such report which is made when the House
21 is not in session shall be filed with the Clerk of the House.

22 (b)(1) The Select Committee on Aging shall report
23 to the House with respect to the results of any investiga-
24 tion or study it conducts.

1 (2) The select committee shall submit an annual re-
2 port to the House which shall include a summary of the
3 activities of the select committee during the calendar year
4 to which the report applies.

5 (3) Any such report which is made when the House
6 is not in session shall be filed with the Clerk of the House.

7 (c)(1) The Select Committee on Hunger shall submit
8 an annual report to the House which shall include a sum-
9 mary of the activities of the select committee during the
10 calendar year to which the report applies.

11 (2) Any such report which is made when the House
12 is not in session shall be filed with the Clerk of the House.

13 (3) The records, files, and materials of the select
14 committee shall be transferred to the Clerk of the House.

15 (d)(1) The Select Committee on Children, Youth, and
16 Families shall report to the House as soon as practicable
17 during the present Congress, the results of its investiga-
18 tion and study, together with such recommendations as
19 it deems advisable.

20 (2) Any such report which is made when the House
21 is not in session shall be filed with the Clerk of the House.

22 (3) Any such report shall be referred to the com-
23 mittee or committees having jurisdiction over the subject
24 matter thereof.

1 (4) The records, files, and materials of the select
2 committee shall be transferred to the Clerk of the House.
