Mr. MOAKLEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 4448) to amend the Act establishing Lowell National Historical Park, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 4448) to amend the Act establishing  
6 Lowell National Historical Park, and for other purposes.  
7 The first reading of the bill shall be dispensed with. Gen-

1 eral debate shall be confined to the bill and shall not ex-  
2 ceed one hour equally divided and controlled by the chair-  
3 man and ranking minority member of the Committee on  
4 Natural Resources. After general debate the bill shall be  
5 considered for amendment under the five-minute rule. It  
6 shall be in order to consider as an original bill for the  
7 purpose of amendment under the five-minute rule the  
8 amendment in the nature of a substitute recommended by  
9 the Committee on Natural Resources now printed in the  
10 bill. The committee amendment in the nature of a sub-  
11 stitute shall be considered as read. Points of order against  
12 the committee amendment in the nature of a substitute  
13 for failure to comply with clause 5(a) of rule XXI are  
14 waived. At the conclusion of consideration of the bill for  
15 amendment the Committee shall rise and report the bill  
16 to the House with such amendments as may have been  
17 adopted. Any Member may demand a separate vote in the  
18 House on any amendment adopted in the Committee of  
19 the Whole to the bill or to the committee amendment in  
20 the nature of a substitute. The previous question shall be  
21 considered as ordered on the bill and amendments thereto  
22 to final passage without intervening motion except one  
23 motion to recommit with or without instructions.
