Mr. MOAKLEY, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 4422) to authorize appropriations for fiscal year 1995 for the Coast Guard, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 4422) to authorize appropriations
6 for fiscal year 1995 for the Coast Guard, and for other
7 purposes. The first reading of the bill shall be dispensed

1 with. All points of order against consideration of the bill
2 are waived. General debate shall be confined to the bill
3 and shall not exceed one hour equally divided and con-
4 trolled by the chairman and ranking minority member of
5 the Committee on Merchant Marine and Fisheries. After
6 general debate the bill shall be considered for amendment
7 under the five-minute rule. It shall be in order to consider
8 as an original bill for the purpose of amendment under
9 the five-minute rule the amendment in the nature of a sub-
10 stitute recommended by the Committee on Merchant Ma-
11 rine and Fisheries now printed in the bill. The committee
12 amendment in the nature of a substitute shall be consid-
13 ered by title rather than by section. Each title shall be
14 considered as read. All points of order against the commit-
15 tee amendment in the nature of a substitute are waived.
16 All points of order against amendments printed in the re-
17 port of the Committee on Rules accompanying this resolu-
18 tion are waived. At the conclusion of consideration of the
19 bill for amendment the Committee shall rise and report
20 the bill to the House with such amendments as may have
21 been adopted. Any Member may demand a separate vote
22 in the House on any amendment adopted in the Commit-
23 tee of the Whole to the bill or to the committee amend-
24 ment in the nature of a substitute. The previous question
25 shall be considered as ordered on the bill and amendments

- 1 thereto to final passage without intervening motion except
- 2 one motion to recommit with or without instructions.
