Mr. DERRICK, from the Committee on Rules, reported the following resolution;  
which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the concurrent resolution (H.  
Con. Res. 301) expressing the sense of the Congress  
regarding entitlements.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the concurrent resolution (H. Con. Res. 301) ex-  
6 pressing the sense of the Congress regarding entitlements.  
7 General debate shall be confined to the concurrent resolu-

1 tion and the amendments made in order by this resolution  
2 and shall not exceed one hour equally divided and con-  
3 trolled by the chairman and ranking minority member of  
4 the Committee on Government Operations. After general  
5 debate the concurrent resolution shall be considered for  
6 amendment under the five-minute rule and shall be consid-  
7 ered as read, and the question on adopting the amendment  
8 numbered 1 in the report of the Committee on Rules ac-  
9 companying this resolution shall be considered as pending  
10 without intervening motion or debate. No other amend-  
11 ment shall be in order except those printed in the report  
12 of the Committee on Rules. Each other amendment may  
13 be offered only in the order printed in the report, may  
14 be offered only by a Member designated in the report,  
15 shall be considered as read, shall be debatable for the time  
16 specified in the report equally divided and controlled by  
17 the proponent and an opponent, and shall not be subject  
18 to amendment. All points of order against amendments  
19 printed in the report are waived. At the conclusion of con-  
20 sideration of the concurrent resolution for amendment, the  
21 Committee shall rise and report the concurrent resolution  
22 to the House with such amendments as may have been  
23 adopted. The previous question shall be considered as or-  
24 dered on the concurrent resolution and amendments there-

- 1 to to final adoption without intervening motion or demand
- 2 for division of the question.
