AN ACT

To amend the Goals 2000: Educate America Act to eliminate the National Education Standards and Improvement Council, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ELIMINATION OF THE NATIONAL EDUCATION**
4 **STANDARDS AND IMPROVEMENT COUNCIL.**

5 (a) REPEALS.—Subsection (b) of section 241, sec-
6 tions 211 through 218 of Part B of title II, and section
7 316 of the Goals 2000: Educate America Act (20 U.S.C.
8 5841 et seq.) are repealed.

1 (b) AMENDMENTS TO GOALS 2000: EDUCATE AMER-
2 ICA ACT.—

3 (1) Section 201(3) of the Goals 2000: Educate
4 America Act (20 U.S.C. 5812(3)) is amended by
5 striking all that follows after “opportunity-to-learn
6 standards” and inserting a period.

7 (2) Section 203(a) of such Act (20 U.S.C.
8 5823(a)) is amended by striking paragraphs (3) and
9 (4) and by redesignating paragraphs (5) and (6) as
10 paragraphs (3) and (4), respectively.

11 (3) Section 204(a)(2) of such Act (20 U.S.C.
12 5824) is amended by striking “described in section
13 213(f)”.

14 (4) Section 219 of such Act (20 U.S.C. 5849)
15 is amended—

16 (A) in subsection (a)(1) by striking “con-
17 sistent with the provisions of section 213(c),”;
18 and

19 (B) by striking subsection (b) and insert-
20 ing the following:

21 “(b) APPLICATIONS.—Each consortium that desires
22 to receive a grant under this subsection shall submit an
23 application to the Secretary at such time, in such manner,
24 and containing such information and assurances as the
25 Secretary may require.”.

1 (5) Section 220(a) of such Act (20 U.S.C.
2 5850(a)) is amended by striking “to be used” and
3 all that follows through “by the Council”.

4 (6) Section 221(a) of such Act (20 U.S.C.
5 5851(a)) is amended—

6 (A) in paragraph (1)—

7 (i) subparagraph (A), by striking
8 “and the Council”; and

9 (ii) striking subparagraph (B) and
10 (C) and redesignating subparagraph (D)
11 as subparagraph (B); and

12 (B) in paragraph (2), by striking “and the
13 Council, as appropriate,”.

14 (7) Section 308(b)(2)(A) of such Act (20
15 U.S.C. 5888(b)(2)(A)) is amended by striking “in-
16 cluding—” and all that follows through the end of
17 clause (ii) and inserting “including through consor-
18 tia of States”.

19 (8) Section 314(a)(6) of such Act (20 U.S.C.
20 5894(a)(6)) is amended by striking “, if—” and all
21 that follows through “(B)” and inserting “if”.

22 (9) Section 315 of such Act (20 U.S.C. 5895)
23 is amended in subsection (b)—

1 (A) paragraph (1)(A), by striking “para-
2 graph (4) of this subsection” and inserting
3 “paragraph (3)”;

4 (B) by striking paragraph (2);

5 (C) by redesignating paragraphs (3)
6 through (5) as paragraphs (2) through (4), re-
7 spectively;

8 (D) in subparagraph (B) of paragraph (3)
9 (as redesignated), by striking “paragraph (5),”
10 and inserting “paragraph (4),”; and

11 (E) in paragraph (4) (as redesignated), by
12 striking “paragraph (4)” each place it appears
13 and inserting “paragraph (3)”.

14 (c) NATIONAL SKILL STANDARDS ACT OF 1994.—

15 (1) Section 503 of the National Skill Standards
16 Act of 1994 (20 U.S.C. 5933) is amended—

17 (A) in subsection (b)—

18 (i) in paragraph (1)—

19 (I) in the matter preceding sub-
20 paragraph (A), by striking “28” and
21 inserting “27”;

22 (II) by striking subparagraph
23 (D); and

1 (III) by redesignating subpara-
2 graphs (E) through (G) as subpara-
3 graphs (D) through (F), respectively;

4 (ii) in paragraphs (2), (3), and (5), by
5 striking “subparagraphs (E), (F), and
6 (G)” each place it appears and inserting
7 “subparagraphs (D), (E), and (F)”;

8 (iii) in paragraph (2), by striking
9 “subparagraph (G)” and inserting “sub-
10 paragraph (F)”;

11 (iv) in paragraph (4), by striking
12 “(C), and (D)” and inserting “and (C)”;
13 and

14 (v) in the matter preceding subpara-
15 graph (A) of paragraph (5), by striking
16 “subparagraph (E), (F), or (G)” and in-
17 serting “subparagraph (D), (E), or (F)”;
18 and

19 (B) in subsection (c)—

20 (i) in paragraph (1)(B), by striking
21 “subparagraph (E)” and inserting “sub-
22 paragraph (D)”;

23 (ii) in paragraph (2), by striking
24 “subparagraphs (E), (F), and (G)” and in-

1 serting “subparagraphs (D), (E), and
2 (F)”.

3 (2) Section 504 of such Act (20 U.S.C. 5934)
4 is amended—

5 (A) by striking subsection (f); and

6 (B) by redesignating subsection (g) as sub-
7 section (f).

8 (d) AMENDMENT TO ELEMENTARY AND SECONDARY
9 EDUCATION ACT OF 1965.—Section 14701(b)(1)(B)(v) of
10 such the Elementary and Secondary Education Act of
11 1965 (20 U.S.C. 8941(b)(1)(B)(v)) is amended—

12 (1) by inserting “and” before “the National
13 Education Goals Panel”; and

14 (2) by striking “, and the National Education
15 Statistics and Improvement Council”.

16 (d) AMENDMENT TO GENERAL EDUCATION PROVI-
17 SIONS ACT.—Section 428 of the General Education Provi-
18 sions Act (20 U.S.C. 1228b), as amended by section 237
19 of the Improving America’s Schools Act of 1994 (Public
20 Law 103–382), is amended by striking “the National Edu-
21 cation Standards and Improvement Council,”.

22 **SEC. 2. TECHNICAL AND CONFORMING AMENDMENTS.**

23 The table of contents for the Goals 2000: Educate
24 America Act is amended, in the items relating to title II,
25 by striking the items relating to sections 211 through 218

1 of part B of such title and the item relating to section
2 316.
