*April 6 (legislative day, April 5), 1995.*

*Resolved*, That the bill from the House of Representatives (H.R. 1158) entitled “An Act making emergency supplemental appropriations for additional disaster assistance and making rescissions for the fiscal year ending September 30, 1995, and for other purposes”, do pass with the following

(B) includes the removal of associated trees or trees lacking the characteristics of a healthy and viable ecosystem for the purpose of ecosystem improvement or rehabilitation, except that any such sale must include an identifiable salvage component of trees described in the first sentence.

(2) DIRECTION TO COMPLETE SALVAGE TIMBER SALES.—Notwithstanding any other law (including a law under the authority of which any judicial order may be outstanding on or after the date of enactment

19 *SEC. 2008. None of the funds made available in any*

23 *lished by section 105 of the Comprehensive Environmental*

4 *SEC. 2009.* No part of any appropriation contained

7 ***SEC. 2010. SENSE OF THE SENATE REGARDING TAX AVOID-***  
8 ***ANCE.***

9 (a) *IN GENERAL.*—It is the sense of the Senate that  
10 Congress should act as quickly as possible to amend the In-  
11 ternal Revenue Code of 1986, to eliminate the ability of per-  
12 sons to avoid taxes by relinquishing their United States  
13 citizenship.

14 (b) *EFFECTIVE DATE.*—It is the sense of the Senate  
15 that the amendment referred to in subsection (a) should take  
16 effect as if enacted on February 6, 1995.

17 *SEC. 2011.* (a) As provided in subsection (b), an envi-  
18 ronmental impact statement prepared pursuant to the Na-

11 *Of the funds available to the agencies of the Federal*  
12 *Government, \$337,000,000 are hereby rescinded: Provided,*  
13 *That rescissions pursuant to this paragraph shall be taken*  
14 *only from administrative and travel accounts: Provided*  
15 *further, That rescissions shall be taken on a pro rata basis*  
16 *from funds available to every Federal agency, department,*  
17 *and office, including the Office of the President.*

18 *SEC. 2013. (a) SCHEDULE FOR NEPA COMPLIANCE.—*  
19 *Each National Forest System unit shall establish and ad-*  
20 *here to a schedule for the completion of National Environ-*  
21 *mental Policy Act of 1969 (42 U.S.C. 4321 et seq.) analysis*  
22 *and decisions on all allotments within the National Forest*  
23 *System unit for which NEPA analysis is needed. The sched-*  
24 *ule shall provide that not more than 20 percent of the allot-*

1 *ments shall undergo NEPA analysis and decisions through*  
2 *fiscal year 1996.*

3 *(b) REISSUANCE PENDING NEPA COMPLIANCE.—Not-*  
4 *withstanding any other law, term grazing permits which*  
5 *expire or are waived before the NEPA analysis and decision*  
6 *pursuant to the schedule developed by individual Forest*  
7 *Service System units, shall be issued on the same terms and*  
8 *conditions and for the full term of the expired or waived*  
9 *permit. Upon completion of the scheduled NEPA analysis*  
10 *and decision for the allotment, the terms and conditions of*  
11 *existing grazing permits may be modified or re-issued, if*  
12 *necessary to conform to such NEPA analysis.*

13 *(c) EXPIRED PERMITS.—This section shall only apply*
