AN ACT

To adjust the boundaries of Paterson Great Falls National Historical Park to include Hinchliffe Stadium, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Hinchliffe Stadium
3 Heritage Act”.

4 **SEC. 2. PATERSON GREAT FALLS NATIONAL HISTORICAL**
5 **PARK BOUNDARY ADJUSTMENT.**

6 Section 7001 of the Omnibus Public Land Manage-
7 ment Act of 2009 (16 U.S.C. 410lll) is amended as fol-
8 lows:

9 (1) In subsection (b)(3)—

10 (A) by striking “The Park shall” and in-
11 serting “(A) The Park shall”;

12 (B) by redesignating subparagraphs (A)
13 through (G) as clauses (i) through (vii), respec-
14 tively; and

15 (C) by adding at the end the following:

16 “(B) In addition to the lands described in sub-
17 paragraph (A), the Park shall include the approxi-
18 mately 6 acres of land containing Hinchliffe Sta-
19 dium and generally depicted as the ‘Boundary Modi-
20 fication Area’ on the map entitled ‘Paterson Great
21 Falls National Historical Park, Proposed Boundary
22 Modification’, numbered T03/120,155, and dated
23 April 2014, which shall be administered as part of
24 the Park in accordance with subsection (c)(1) and
25 section 3 of the Hinchliffe Stadium Heritage Act.”.

1 (2) In subsection (b)(4), by striking “The Map”
2 and inserting “The Map and the map referred to in
3 paragraph (3)(B)”.

4 (3) In subsection (c)(4)—

5 (A) in subparagraph (A), by striking “The
6 Secretary” and inserting “Except as provided
7 in subparagraphs (B) and (C), the Secretary”;
8 and

9 (B) by inserting after subparagraph (B)
10 the following:

11 “(C) HINCHLIFFE STADIUM.—The Sec-
12 retary may not acquire fee title to Hinchliffe
13 Stadium, but may acquire a preservation ease-
14 ment in Hinchliffe Stadium if the Secretary de-
15 termines that doing so will facilitate resource
16 protection of the stadium.”.

17 **SEC. 3. ADDITIONAL CONSIDERATIONS FOR HINCHLIFFE**
18 **STADIUM.**

19 In administering the approximately 6 acres of land
20 containing Hinchliffe Stadium and generally depicted as
21 the “Boundary Modification Area” on the map entitled
22 “Paterson Great Falls National Historical Park, Proposed
23 Boundary Modification”, numbered T03/120,155, and
24 dated April 2014, the Secretary of the Interior—

1 (1) may not include non-Federal property with-
2 in the approximately 6 acres of land as part of
3 Paterson Great Falls National Historical Park with-
4 out the written consent of the owner;

5 (2) may not acquire by condemnation any land
6 or interests in land within the approximately 6 acres
7 of land; and

8 (3) shall not construe this Act or the amend-
9 ments made by this Act to create buffer zones out-
10 side the boundaries of the Paterson Great Falls Na-
11 tional Historical Park. That activities or uses can be
12 seen, heard or detected from areas within the ap-
13 proximately 6 acres of land added to the Paterson
14 Great Falls National Historical Park by this Act
15 shall not preclude, limit, control, regulate or deter-
16 mine the conduct or management of activities or
17 uses outside of the Paterson Great Falls National
18 Historical Park.
