# **A BILL**

To adjust the boundaries of Paterson Great Falls National Historical Park to include Hinchliffe Stadium, and for other purposes.

1        *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Hinchliffe Stadium Her-*  
 5 *itage Act”.*

6 **SEC. 2. PATERSON GREAT FALLS NATIONAL HISTORICAL**  
 7 **PARK BOUNDARY ADJUSTMENT.**

8        *Section 7001 of the Omnibus Public Land Manage-*  
 9 *ment Act of 2009 (16 U.S.C. 410lll) is amended as follows:*

10            (1) *In subsection (b)(3)—*

11                    (A) *by striking “The Park shall” and in-*  
 12 *serting “(A) The Park shall”;*

13                    (B) *by redesignating subparagraphs (A)*  
 14 *through (G) as clauses (i) through (vii), respec-*  
 15 *tively; and*

16                    (C) *by adding at the end the following:*

17                    “(B) *In addition to the lands described in sub-*  
 18 *paragraph (A), the Park shall include the approxi-*  
 19 *mately 6 acres of land containing Hinchliffe Stadium*  
 20 *and generally depicted as the ‘Boundary Modification*  
 21 *Area’ on the map entitled ‘Paterson Great Falls Na-*  
 22 *tional Historical Park, Proposed Boundary Modifica-*  
 23 *tion’, numbered T03/120,155, and dated April 2014,*  
 24 *which shall be administered as part of the Park in ac-*

1 cordance with subsection (c)(1) and section 3 of the  
2 *Hinchliffe Stadium Heritage Act.*”.

3 (2) *In subsection (b)(4), by striking “The Map”*  
4 *and inserting “The Map and the map referred to in*  
5 *paragraph (3)(B).”*.

6 (3) *In subsection (c)(4)—*

7 (A) *in subparagraph (A), by striking “The*  
8 *Secretary” and inserting “Except as provided in*  
9 *subparagraphs (B) and (C), the Secretary”; and*

10 (B) *by inserting after subparagraph (B) the*  
11 *following:*

12 “(C) *HINCHLIFFE STADIUM.—The Secretary*  
13 *may not acquire fee title to Hinchliffe Stadium,*  
14 *but may acquire a preservation easement in*  
15 *Hinchliffe Stadium if the Secretary determines*  
16 *that doing so will facilitate resource protection of*  
17 *the stadium.”.*

18 **SEC. 3. ADDITIONAL CONSIDERATIONS FOR HINCHLIFFE**

19 **STADIUM.**

20 *In administering the approximately 6 acres of land*  
21 *containing Hinchliffe Stadium and generally depicted as*  
22 *the “Boundary Modification Area” on the map entitled*  
23 *“Paterson Great Falls National Historical Park, Proposed*  
24 *Boundary Modification”, numbered T03/120,155, and*  
25 *dated April 2014, the Secretary of the Interior—*

1           (1) *may not include non-Federal property with-*  
2 *in the approximately 6 acres of land as part of*  
3 *Paterson Great Falls National Historical Park with-*  
4 *out the written consent of the owner;*

5           (2) *may not acquire by condemnation any land*  
6 *or interests in land within the approximately 6 acres*  
7 *of land; and*

8           (3) *shall not construe this Act or the amend-*  
9 *ments made by this Act to create buffer zones outside*  
10 *the boundaries of the Paterson Great Falls National*  
11 *Historical Park. That activities or uses can be seen,*  
12 *heard or detected from areas within the approxi-*  
13 *mately 6 acres of land added to the Paterson Great*  
14 *Falls National Historical Park by this Act shall not*  
15 *preclude, limit, control, regulate or determine the con-*  
16 *duct or management of activities or uses outside of*  
17 *the Paterson Great Falls National Historical Park.*
