A BILL

To amend title 38, United States Code, to extend the period of eligibility for inpatient care for veterans exposed to toxic substances, radiation, or environmental hazards, to extend the period of eligibility for outpatient care for veterans exposed to such substances or hazards during service in the Persian Gulf, and to expand the eligibility of veterans exposed to toxic substances or radiation for outpatient care.

1 **SECTION 1. EXTENSION OF PERIOD OF ELIGIBILITY FOR**
2 **INPATIENT CARE.**

3 (a) CARE FOR EXPOSURE TO TOXIC SUBSTANCES
4 AND IONIZING RADIATION.—Section 1710(e)(3) of title
5 38, United States Code, is amended by striking out “June
6 30, 1995,” and inserting in lieu thereof “December 31,
7 2003,”.

8 (b) CARE FOR EXPOSURE DURING PERSIAN GULF
9 SERVICE.—Such section is further amended by striking
10 out “December 31, 1995” and inserting in lieu thereof
11 “December 31, 2003”.

12 **SEC. 2. EXTENSION AND EXPANSION OF ELIGIBILITY FOR**
13 **OUTPATIENT CARE.**

14 (a) EXTENSION OF ELIGIBILITY FOR EXPOSURE
15 DURING PERSIAN GULF SERVICE.—Paragraph (1)(D) of
16 section 1712(a) of title 38, United States Code, is amend-
17 ed by striking out “December 31, 1995,” and inserting
18 in lieu thereof “December 31, 2003,”.

19 (b) EXPANSION OF ELIGIBILITY TO COVER TOXIC
20 SUBSTANCES AND IONIZING RADIATION.—Such section is
21 further amended—

22 (1) in paragraph (1)—

23 (A) by striking out “and” at the end of
24 subparagraph (C);

1 (B) by striking out the period at the end
2 of subparagraph (D) and inserting in lieu there-
3 of a semicolon; and

4 (C) by adding at the end the following new
5 subparagraphs:

6 “(E) during the period before December 31,
7 2003, for any disability in the case of a veteran who
8 served on active duty in the Republic of Vietnam
9 during the Vietnam era and who the Secretary finds
10 may have been exposed during such service to dioxin
11 or was exposed during such service to a toxic sub-
12 stance found in a herbicide or defoliant used in con-
13 nection with military purposes during such era, not-
14 withstanding that there is insufficient medical evi-
15 dence to conclude that the disability may be associ-
16 ated with such exposure; and

17 “(F) during the period before December 31,
18 2003, for any disability in the case of a veteran who
19 the Secretary finds was exposed while serving on ac-
20 tive duty to ionizing radiation from the detonation of
21 a nuclear device in connection with such veteran’s
22 participation in the test of such a device or with the
23 American occupation of Hiroshima and Nagasaki,
24 Japan, during the period beginning on September
25 11, 1945, and ending on July 1, 1946, notwith-

1 standing that there is insufficient medical evidence
2 to conclude that the disability may be associated
3 with such exposure.”; and

4 (2) in paragraph (7)—

5 (A) by striking out “under paragraph
6 (1)(D)” and inserting in lieu thereof “under
7 subparagraph (D), (E), or (F) of paragraph (1)
8 of this subsection”; and

9 (B) by striking out “in that paragraph”
10 and inserting in lieu thereof “in the applicable
11 subparagraph”.
