1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CLARIFYING CERTAIN PROPERTY DESCRIP-**
4 **TIONS IN PROVO RIVER PROJECT TRANSFER**
5 **ACT.**

6 (a) PLEASANT GROVE PROPERTY.—Section 2(4)(A)
7 of the Provo River Project Transfer Act (Public Law 108–
8 382; 118 Stat. 2212) is amended by striking “of enact-
9 ment of this Act” and inserting “on which the parcel is
10 conveyed under section 3(a)(2)”.

11 (b) PROVO RESERVOIR CANAL.—Section 2(5) of the
12 Provo River Project Transfer Act (Public Law 108–382;
13 118 Stat. 2212) is amended—

14 (1) by striking “canal, and any associated land,
15 rights-of-way, and facilities” and inserting “water
16 conveyance facility historically known as the Provo
17 Reservoir Canal and all associated bridges, fixtures,
18 structures, facilities, lands, interests in land, and
19 rights-of-way held,”;

20 (2) by inserting “and forebay” after “Diversion
21 Dam”;

22 (3) by inserting “near the Jordan Narrows to
23 the point where water is discharged to the Welby-
24 Jacob Canal and the Utah Lake Distributing Canal”
25 after “Penstock”; and

1 (4) by striking “of enactment of this Act” and
2 inserting “on which the Provo Reservoir Canal is
3 conveyed under section 3(a)(1)”.
