## A BILL

To require the President to submit to the Congress each year an integrated justification for United States foreign assistance programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Foreign Aid Reporting  
5 Reform Act of 1995”.

1 **SEC. 2. ANNUAL FOREIGN ASSISTANCE JUSTIFICATION**  
2 **REPORT.**

3 (a) IN GENERAL.—In conjunction with the submis-  
4 sion of the annual requests for enactment of authoriza-  
5 tions and appropriations for foreign assistance programs  
6 for each fiscal year, the President shall submit to the Con-  
7 gress a single report containing—

8 (1) an integrated justification for all foreign as-  
9 sistance programs proposed by the President for the  
10 coming fiscal year; and

11 (2) an assessment of when the objectives of  
12 those programs will be achieved so that the assist-  
13 ance can be terminated.

14 (b) SPECIFIC INFORMATION TO BE PROVIDED.—  
15 Each such report shall include the following:

16 (1) INFORMATION REGARDING A FOREIGN AS-  
17 SISTANCE PROGRAM GENERALLY.—For each foreign  
18 assistance program taken as a whole—

19 (A) the total amount of assistance pro-  
20 posed to be provided under that program;

21 (B) the justification for that amount;

22 (C) the objectives that assistance under  
23 that program is intended to achieve;

24 (D) an explanation of the relationship of  
25 assistance under that program to assistance  
26 under other foreign assistance programs; and

1 (E) the President's estimation of the date  
2 by which the objectives of that program will be  
3 achieved and the program terminated.

4 (2) INFORMATION REGARDING SPECIFIC ASSIST-  
5 ANCE RECIPIENTS.—For each country or organiza-  
6 tion which is a proposed recipient of assistance  
7 under any foreign assistance program—

8 (A) the amount of each type of assistance  
9 proposed;

10 (B) the justification for providing each  
11 such type of assistance;

12 (C) the objectives that each such type of  
13 assistance is intended to achieve;

14 (D) an explanation of the relationship of  
15 each type of assistance proposed to other types  
16 of assistance proposed for that recipient; and

17 (E) the President's estimation of the date  
18 by which the objectives of assistance for such  
19 recipient under each foreign assistance program  
20 will be achieved and assistance under that pro-  
21 gram to that recipient terminated.

22 The information required by subparagraphs (A)  
23 through (E) shall be provided on a recipient-by-  
24 recipient basis.

1           (3) INFORMATION REGARDING CENTRALLY-  
2 FUNDED PROGRAMS.—For each centrally-funded  
3 program under a foreign assistance program—

4           (A) the amount proposed for such pro-  
5 gram;

6           (B) the justification for such program;

7           (C) the objectives each such program is in-  
8 tended to achieve;

9           (D) an explanation of the relationship of  
10 such program to other types of assistance pro-  
11 posed under that foreign assistance program  
12 and under other foreign assistance programs;  
13 and

14           (E) the President's estimation of the date  
15 by which the objectives of such program will be  
16 achieved and such program terminated.

17 **SEC. 3. REQUIREMENT FOR CONGRESSIONAL EXPLA-**  
18 **NATION OF PROPOSED CHANGES TO THE**  
19 **PRESIDENT'S FOREIGN ASSISTANCE BUDGET.**

20           Any committee of the Congress reporting legislation  
21 authorizing the enactment of new budget authority for, or  
22 providing new budget authority for, foreign assistance pro-  
23 grams shall include in the report accompanying that legis-  
24 lation an explanation for any change proposed by that  
25 committee—

1           (1) in the total amount of new budget authority  
2 authorized or provided (as the case may be) for any  
3 foreign assistance program as compared to the  
4 amount proposed by the President; or

5           (2) in the amount of assistance for any specific  
6 recipient of assistance, or for any centrally-funded  
7 program, under any foreign assistance program as  
8 compared to the amount proposed by the President.

9 **SEC. 4. DEFINITION OF FOREIGN ASSISTANCE PROGRAMS.**

10       As used in this Act, the term “foreign assistance pro-  
11 gram” includes—

12           (1) any program of assistance authorized by the  
13 Foreign Assistance Act of 1961 (such as the devel-  
14 opment assistance program, the economic support  
15 fund program, and the international military edu-  
16 cation and training program) or authorized by the  
17 African Development Foundation Act, section 401 of  
18 the Foreign Assistance Act of 1969 (relating to the  
19 Inter-American Development Foundation), or any  
20 other foreign assistance legislation;

21           (2) any program of grant, credit, or guaranty  
22 assistance under the Arms Export Control Act;

23           (3) assistance under the Migration and Refugee  
24 Assistance Act of 1962;

1           (4) assistance under any title of the Agricul-  
2           tural Trade Development and Assistance Act of  
3           1954;

4           (5) contributions to the International Monetary  
5           Fund;

6           (6) contributions to the International Bank for  
7           Reconstruction and Development, the International  
8           Development Association, or any other institution  
9           within the World Bank group; and

10          (7) contributions to any regional multilateral  
11          development bank.
