A BILL

To direct the Secretary of the Interior to make technical corrections to maps relating to the Coastal Barrier Resources System.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. CORRECTIONS TO MAPS.**

4 (a) *IN GENERAL.*—The Secretary of the Interior
 5 shall, before the end of the 30-day period beginning on
 6 the date of the enactment of this Act, make such correc-
 7 tions to the maps described in subsection (b) as are nec-
 8 essary to ensure that depictions of areas on those maps
 9 are consistent with the depictions of areas appearing on
 10 the maps entitled _____; dated
 11 _____; and on file with the Secretary.

12 (b) *MAPS DESCRIBED.*—The maps described in this
 13 subsection are maps that—

14 (1) are included in a set of maps entitled
 15 “Coastal Barrier Resources System”, dated October
 16 24, 1990; and

17 (2) relate to the following units of the Coastal
 18 Barrier Resources System: P04A, P05, P05A, P08,
 19 P10, P11, P11A, P18, P25, FL-90.

20 **SECTION 1. CORRECTIONS TO MAPS.**

21 (a) *IN GENERAL.*—The Secretary of the Interior shall,
 22 before the end of the 30-day period beginning on the date
 23 of the enactment of this Act, make such corrections to the
 24 maps described in subsection (b) as are necessary to ensure
 25 that depictions of areas on those maps are consistent with
