2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. DESIGNATION OF FRANCIS J. HAGEL BUILDING.**

2 The Social Security Administration's Western Pro-  
3 gram Service Center located at 1221 Nevin Avenue, Rich-  
4 mond, California, shall be known and designated as the  
5 "Francis J. Hagel Building".

6 **SEC. 2. REFERENCES.**

7 Any reference in a law, map, regulation, document,  
8 paper, or other record of the United States to the building  
9 referred to in section 1 shall be deemed to be a reference  
10 to the "Francis J. Hagel Building".

11 **SECTION 1. DESIGNATION.**

12 *The Federal building located at 1221 Nevin Avenue in*  
13 *Richmond, California, shall be known and designated as*  
14 *the "Frank Hagel Federal Building".*

15 **SEC. 2. REFERENCES.**

16 *Any reference in a law, map, regulation, document,*  
17 *paper, or other record of the United States to the Federal*  
18 *building referred to in section 1 shall be deemed to be a*  
19 *reference to the "Frank Hagel Federal Building".*

Amend the title so as to read: "A bill to designate the Federal building located at 1221 Nevin Avenue in Richmond, California, as the 'Frank Hagel Federal Building'".
