## A BILL

To authorize appropriations to carry out the Interjurisdictional Fisheries Act of 1986 and the Anadromous Fish Conservation Act.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Cooperative Fisheries  
5 Management Act of 1995”.

6 **SEC. 2. REAUTHORIZATION OF INTERJURISDICTIONAL**  
7 **FISHERIES ACT OF 1986.**

8 Section 308 of the Interjurisdictional Fisheries Act  
9 of 1986 (16 U.S.C. 4107) is amended—

1 (1) by amending subsection (a) to read as fol-  
2 lows:

3 “(a) GENERAL APPROPRIATIONS.—There are author-  
4 ized to be appropriated to the Department of Commerce  
5 for apportionment to carry out the purposes of this title—

6 “(1) \$3,400,000 for fiscal year 1996;

7 “(2) \$3,900,000 for fiscal year 1997; and

8 “(3) \$4,400,000 for fiscal year 1998.”; and

9 (2) in subsection (c) by striking “\$350,000 for  
10 each of the fiscal years 1989, 1990, 1991, 1992, and  
11 1993, and \$600,000 for each of the fiscal years  
12 1994 and 1995,” and inserting “\$650,000 for fiscal  
13 year 1996, \$700,000 for fiscal year 1997, and  
14 \$750,000 for fiscal year 1998.”.

15 **SEC. 3. REAUTHORIZATION OF THE ANADROMOUS FISH**  
16 **CONSERVATION ACT.**

17 Section 4 of the Anadromous Fish Conservation Act  
18 (16 U.S.C. 757d) is amended to read as follows:

19 “SEC. 4. (a) There are authorized to be appropriated  
20 to carry out the purposes of this Act not to exceed the  
21 following sums:

22 “(1) \$4,000,000 for each of fiscal years 1996  
23 and 1997.

24 “(2) \$4,250,000 for fiscal year 1998.

1 Sums appropriated under this subsection are authorized  
2 to remain available until expended.

3 “(b) Not more than \$625,000 of the funds appro-  
4 priated under this section in any one fiscal year shall be  
5 obligated in any one State.”.
