A BILL

To amend Public Law 103-93 to provide additional lands within the State of Utah for the Goshute Indian Reservation, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. ADDITION OF CERTAIN UTAH STATE LANDS TO**
2 **GOSHUTE INDIAN RESERVATION.**

3 The Utah Schools and Lands Improvement Act of
4 1993 (107 Stat. 995) is amended—

5 (1) by redesignating section 11 as section 12;

6 and

7 (2) by inserting after section 10 the following
8 new section:

9 **“SEC. 11. ADDITIONAL GOSHUTE INDIAN RESERVATION**
10 **LANDS.**

11 “(a) **FURTHER ADDITIONS TO GOSHUTE RESERVA-**
12 **TION.**—In addition to the lands described in section 3, for
13 the purpose of securing in trust for the Goshute Indian
14 Tribe certain additional public lands and lands belonging
15 to the State of Utah, which comprise approximately 8,000
16 acres of surface and subsurface estate, as generally de-
17 picted on the map entitled ‘Additional Utah-Goshute Ex-
18 change’, dated July 1, 1994, such public lands and State
19 lands are hereby declared to be part of the Goshute Indian
20 Reservation in the State of Utah effective upon the com-
21 pletion of conveyance of the State lands from the State
22 of Utah and acceptance of title by the United States.

23 “(b) **AUTHORIZATION.**—The Secretary of the Interior
24 is authorized to acquire through exchange those lands and
25 interests in land described in subsection (a) which are

1 owned by the State of Utah, subject to valid existing
2 rights.

3 “(c) APPLICATION OF PRIOR PROVISIONS.—(1) Ex-
4 cept as provided in paragraph (2), the remaining provi-
5 sions of this Act which are applicable to the lands to be
6 transferred to the Goshute Indian Tribe pursuant to sec-
7 tion 3 shall also apply to the lands subject to this section.

8 “(2) The Goshute Indian Tribe will be responsible for
9 payment of the costs of appraisal of the lands to be ac-
10 quired pursuant to this section, which costs shall be paid
11 prior to the transfer of such lands.”.
