A BILL

To extend energy conservation programs under the Energy Policy and Conservation Act through fiscal year 1999, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ENERGY POLICY AND CONSERVATION ACT**
4 **AMENDMENTS.**

5 The Energy Policy and Conservation Act is amend-
6 ed—

7 (1) by amending section 166 (42 U.S.C. 6246)
8 to read as follows:

1 “AUTHORIZATION OF APPROPRIATIONS

2 “SEC. 166. There are authorized to be appropriated
3 for fiscal years 1996 through 1999 such sums as may be
4 necessary to implement this part.”;

5 (2) in section 181 (42 U.S.C. 6251) by striking
6 “June 30, 1996” both places it appears and insert-
7 ing in lieu thereof “September 30, 1999”;

8 (3) by adding at the end of section 256(h) (42
9 U.S.C. 6276(h)) “There are authorized to be appro-
10 priated for fiscal years 1996 through 1999 such
11 sums as may be necessary to carry out this part.”;

12 (4) in section 281 (42 U.S.C. 6285) by striking
13 “June 30, 1996” both places it appears and insert-
14 ing in lieu thereof “September 30, 1999”;

15 (5) in section 365(f)(1) (42 U.S.C. 6325(f)(1))
16 by striking “not to exceed” and all that follows
17 through “fiscal year 1993” and inserting in lieu
18 thereof “for fiscal years 1996 through 1999 such
19 sums as may be necessary”; and

20 (6) by amending section 397 (42 U.S.C. 6371f)
21 to read as follows:

22 “AUTHORIZATION OF APPROPRIATIONS

23 “SEC. 397. For the purpose of carrying out this part,
24 there are authorized to be appropriated for fiscal years
25 1996 through 1999 such sums as may be necessary.”.

1 **SEC. 2. ENERGY CONSERVATION AND PRODUCTION ACT**
2 **AMENDMENT.**

3 Section 422 of the Energy Conservation and Produc-
4 tion Act (42 U.S.C. 6872) is amended to read as follows:

5 "AUTHORIZATION OF APPROPRIATIONS

6 "SEC. 422. For the purpose of carrying out the
7 weatherization program under this part, there are author-
8 ized to be appropriated for fiscal years 1996 through 1999
9 such sums as may be necessary."
