A BILL

To authorize the National Desert Storm Memorial Associa-
tion to establish the National Desert Storm and Desert
Shield Memorial as a commemorative work in the Dis-
trict of Columbia, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “National Desert Storm*
5 *and Desert Shield War Memorial Act”.*

6 **SEC. 2. DEFINITIONS.**

7 *For the purposes of this Act:*

8 (1) *ASSOCIATION.*—*The term “Association”*
9 *means the National Desert Storm Memorial Associa-*
10 *tion, a corporation organized under the laws of the*
11 *State of Arkansas and described in section 501(c)(3)*
12 *and exempt from taxation under section 501(a) of the*
13 *Internal Revenue Code of 1986.*

14 (2) *MEMORIAL.*—*The term “memorial” means*
15 *the National Desert Storm and Desert Shield Memo-*
16 *rial authorized to be established under section 3.*

17 **SEC. 3. MEMORIAL TO COMMEMORATE.**

18 (a) *AUTHORIZATION TO ESTABLISH COMMEMORATIVE*
19 *WORK.*—*The Association may establish the National Desert*
20 *Storm and Desert Shield Memorial as a commemorative*
21 *work, on Federal land in the District of Columbia to com-*
22 *memorate and honor those who, as a member of the Armed*
23 *Forces, served on active duty in support of Operation Desert*
24 *Storm or Operation Desert Shield.*

1 (b) *COMPLIANCE WITH STANDARDS FOR COMMEMORA-*
2 *TIVE WORKS ACT.*—*The establishment of the commemora-*
3 *tive work shall be in accordance with chapter 89 of title*
4 *40, United States Code (commonly known as the “Com-*
5 *memorative Works Act”).*

6 (c) *USE OF FEDERAL FUNDS PROHIBITED.*—*Federal*
7 *funds may not be used to pay any expense of the establish-*
8 *ment of the memorial. The Association shall be solely re-*
9 *sponsible for acceptance of contributions for, and payment*
10 *of the expenses of, the establishment of the memorial.*

11 (d) *DEPOSIT OF EXCESS FUNDS.*—

12 (1) *If upon payment of all expenses for the estab-*
13 *lishment of the memorial (including the maintenance*
14 *and preservation amount required by section*
15 *8906(b)(1) of title 40, United States Code), there re-*
16 *mains a balance of funds received for the establish-*
17 *ment of the commemorative work, the Association*
18 *shall transmit the amount of the balance to the Sec-*
19 *retary of the Interior for deposit in the account pro-*
20 *vided for in section 8906(b)(3) of title 40, United*
21 *States Code.*

22 (2) *If upon expiration of the authority for the*
23 *commemorative work under section 8903(e) of title*
24 *40, United States Code, there remains a balance of*
25 *funds received for the establishment of the commemo-*

1 *rative work, the Association shall transmit the bal-*
2 *ance to a separate account with the National Park*
3 *Foundation for memorials, to be available to the Sec-*
4 *retary of the Interior or the Administrator (as appro-*
5 *priate) following the process provided in section*
6 *8906(b)(4) of title 40, United States Code, for ac-*
7 *counts established under section 8906(b)(2) or (3) of*
8 *title 40, United States Code.*
