## A BILL

To provide for disposal of public lands in support of the Manzanar Historic Site in the State of California, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TERMINATION OF WITHDRAWALS.**

4 (a) UNAVAILABILITY OF CERTAIN LANDS.—The  
5 Congress, by enacting the Act entitled “An Act to estab-  
6 lish the Manzanar National Historic Site in the State of  
7 California, and for other purposes”, approved March 3,  
8 1992 (106 Stat. 40; Public Law 102–248), (1) provided  
9 for the protection and interpretation of the historical, cul-  
10 tural, and natural resources associated with the relocation

1 of Japanese-Americans during World War II and estab-  
2 lished the Manzanar National Historic Site in the State  
3 of California, and (2) authorized the Secretary of the Inte-  
4 rior to acquire lands or interests therein within the bound-  
5 ary of the Historic Site by donation, purchase with do-  
6 nated or appropriated funds, or by exchange. The public  
7 lands identified for disposal in the Bureau of Land Man-  
8 agement's Bishop Resource Area Resource Management  
9 Plan that could be made available for exchange in support  
10 of acquiring lands within the boundary of the Historic Site  
11 are currently unavailable for this purpose because they are  
12 withdrawn by an Act of Congress.

13 (b) TERMINATION OF WITHDRAWAL.—To provide a  
14 land base with which to allow land exchanges in support  
15 of acquiring lands within the boundary of the Manzanar  
16 National Historic Site, the withdrawal of the following de-  
17 scribed lands is terminated and such lands shall not be  
18 subject to the Act of March 4, 1931 (chap. 517; 46 Stat.  
19 1530):

16 (c) AVAILABILITY OF LANDS.—Upon enactment of  
17 this Act, the lands specified in subsection (a) shall be open  
18 to operation of the public land laws, including the mining  
19 and mineral leasing laws, only after the Secretary of the  
20 Interior has published a notice in the Federal Register  
21 opening such lands.
