A BILL

To reauthorize and extend the Paul D. Wellstone Muscular Dystrophy Community Assistance, Research, and Education Amendments of 2008.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Paul D. Wellstone Mus-*
5 *cular Dystrophy Community Assistance, Research and*
6 *Education Amendments of 2014”.*

7 **SEC. 2. INITIATIVE THROUGH THE DIRECTOR OF THE NA-**
8 **TIONAL INSTITUTES OF HEALTH.**

9 *Section 404E of the Public Health Service Act (42*
10 *U.S.C. 283g) is amended—*

11 *(1) in subsection (a)(1)—*

12 *(A) by striking “Muscoskeletal” and insert-*
13 *ing “Musculoskeletal”; and*

14 *(B) by inserting “Becker, congenital mus-*
15 *cular dystrophy, limb-girdle muscular dys-*
16 *trophy,” after “Duchenne,”;*

17 *(2) in subsection (b)—*

18 *(A) in paragraph (2)—*

19 *(i) by striking “genetics,” at the second*
20 *place it appears; and*

21 *(ii) by inserting “cardiac and pul-*
22 *monary function, and” after “imaging,”;*
23 *and*

24 *(B) in paragraph (3), by inserting “and*
25 *sharing of data” after “regular communication”;*

1 (3) *in subsection (d)—*

2 (A) *in paragraph (2)—*

3 (i) *in the matter preceding subpara-*
4 *graph (A), by striking “15” and inserting*
5 *“18”; and*

6 (ii) *in subparagraph (A)—*

7 (I) *by striking “and the Food and*
8 *Drug Administration” and inserting “,*
9 *the Food and Drug Administration,*
10 *and the Administration for Commu-*
11 *nity Living”;*

12 (II) *by inserting “and adults”*
13 *after “children”; and*

14 (III) *by striking “such as the De-*
15 *partment of Education” and inserting*
16 *“including the Department of Edu-*
17 *cation and the Social Security Admin-*
18 *istration”; and*

19 (B) *in paragraph (4)(B), by inserting “,*
20 *but shall meet no fewer than two times per cal-*
21 *endar year” before the period; and*

22 (4) *in subsection (e)—*

23 (A) *in paragraph (1)—*

24 (i) *in the matter preceding subpara-*
25 *graph (A), by striking “through the na-*

1 *tional research institutes” and inserting*
2 *“through the agencies represented on the Co-*
3 *ordinating Committee pursuant to sub-*
4 *section (d)(2)(A)”;* and

5 *(ii) in subparagraph (A)—*

6 *(I) by inserting “public services,”*
7 *before “and rehabilitative issues”;* and

8 *(II) by inserting “, studies to*
9 *demonstrate the cost-effectiveness of*
10 *providing independent living resources*
11 *and support to patients with various*
12 *forms of muscular dystrophy, and*
13 *studies to determine optimal clinical*
14 *care interventions for adults with var-*
15 *ious forms of muscular dystrophy”*
16 *after “including studies of the impact*
17 *of such diseases in rural and under-*
18 *served communities”;* and

19 *(B) in paragraph (2)(D), by inserting after*
20 *“including new biological agents” the following:*
21 *“and new clinical interventions to improve the*
22 *health of those with muscular dystrophy”.*

1 **SEC. 3. SURVEILLANCE AND RESEARCH REGARDING MUS-**
2 **CULAR DYSTROPHY.**

3 *The second sentence of section 317Q(b) of the Public*
4 *Health Service Act (42 U.S.C. 247b–18(b)) is amended by*
5 *inserting before the period the following: “and, to the extent*
6 *possible, ensure that data be representative of all affected*
7 *populations and shared in a timely manner”.*

8 **SEC. 4. INFORMATION AND EDUCATION.**

9 *Section 5(c) of the Muscular Dystrophy Community*
10 *Assistance, Research and Education Amendments of 2001*
11 *(42 U.S.C. 247b–19(c)) is amended—*

12 *(1) in paragraph (2)—*

13 *(A) by inserting “for pediatric and adult*
14 *patients, including acute care considerations,”*
15 *after “issuance of care considerations”;*

16 *(B) by inserting “various” before “other*
17 *forms of muscular dystrophy”; and*

18 *(C) by striking “and” at the end;*

19 *(2) by redesignating paragraph (3) as para-*
20 *graph (4);*

21 *(3) by inserting after paragraph (2) the fol-*
22 *lowing:*

23 *“(3) in developing and updating care consider-*
24 *ations under paragraph (2), incorporate strategies*
25 *specifically responding to the findings of the national*
26 *transitions survey of minority, young adult, and*

1 *adult communities of muscular dystrophy patients;*
2 *and”;* *and*
3 *(4) in paragraph (4), as redesignated, by insert-*
4 *ing “various” before “other forms of muscular dys-*
5 *trophy”.*

Amend the title so as to read: “A bill to amend the Public Health Service Act relating to Federal research on muscular dystrophy, and other purposes.”.
