A BILL

To amend title XVIII of the Social Security Act to provide for coverage of qualified acupuncturist services under part B of the Medicare Program, and to amend title 5, United States Code, to provide for coverage of such services under the Federal Employees Health Benefits Program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Federal Acupuncture
3 Coverage Act of 1996”.

4 **SEC. 2. COVERAGE OF ACUPUNCTURIST SERVICES UNDER**
5 **MEDICARE.**

6 (a) IN GENERAL.—Section 1861(s)(2) of the Social
7 Security Act (42 U.S.C. 1395x(s)(2)) is amended—

8 (1) by striking “and” at the end of subpara-
9 graphs (N) and (O); and

10 (2) by inserting after subparagraph (O) the fol-
11 lowing new subparagraph:

12 “(P) qualified acupuncturist services (as de-
13 fined in subsection (oo)); and”.

14 (b) PAYMENT RULES.—

15 (1) DETERMINATION OF AMOUNT OF PAY-
16 MENT.—Section 1833(a)(1) of such Act (42 U.S.C.
17 1395l(a)(1)) is amended—

18 (A) by striking “and” before “(P)”, and

19 (B) by striking the semicolon at the end
20 and inserting the following: “, and (Q) with re-
21 spect to qualified acupuncturist services de-
22 scribed in section 1861(s)(2)(P), the amounts
23 paid shall be the amount determined by a fee
24 schedule established by the Secretary for pur-
25 poses of this subparagraph (but in no event
26 shall such amount exceed 65 percent of the fee

1 schedule amount provided under section 1848
2 for the same service performed by a physi-
3 cian);”.

4 (2) SEPARATE PAYMENT FOR SERVICES
5 OF INSTITUTIONAL PROVIDERS.—Section
6 1832(a)(2)(B)(iii) of such Act (42 U.S.C.
7 1395k(a)(2)(B)(iii)) is amended—

8 (A) by striking “and services” and insert-
9 ing “services”; and

10 (B) by striking the semicolon at the end
11 and inserting the following: “, and qualified
12 acupuncturist services described in section
13 1861(s)(2)(P);”.

14 (c) SERVICES DESCRIBED.—Section 1861 of such
15 Act (42 U.S.C. 1395x) is amended by adding at the end
16 the following new subsection:

17 “Qualified Acupuncturist Services

18 “(oo)(1) The term ‘qualified acupuncturist services’
19 means such services furnished by a qualified acupuncturist
20 (as defined in paragraph (2)) and such services and sup-
21 plies furnished as an incident to services furnished by the
22 qualified acupuncturist which the qualified acupuncturist
23 is legally authorized to perform under State law (or the
24 State regulatory mechanism provided by State law).

1 “(2) The term ‘qualified acupuncturist’ means an in-
2 dividual who has been certified, licensed, or registered as
3 an acupuncturist by a State (or the State regulatory
4 mechanism provided by State law).”.

5 (d) EFFECTIVE DATE.—The amendments made by
6 this section shall apply to services furnished on or after
7 January 1, 1997.

8 **SEC. 3. COVERAGE OF ACUPUNCTURIST SERVICES UNDER**
9 **FEDERAL EMPLOYEES HEALTH BENEFIT**
10 **PLANS.**

11 (a) IN GENERAL.—Section 8902(k)(1) of title 5,
12 United States Code, is amended by inserting
13 “acupuncturist,” after “nurse midwife,” each place it ap-
14 pears.

15 (b) APPLICABILITY.—The amendment made by sub-
16 section (a) shall apply with respect to services provided
17 after December 31, 1996.
