A BILL

To name the Mountain Home Department of Veterans Affairs medical center in Johnson City, Tennessee, as the “James H. Quillen Department of Veterans Affairs Medical Center”.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. NAME OF DEPARTMENT OF VETERANS AFFAIRS**
2 **MEDICAL CENTER, JOHNSON CITY, TEN-**
3 **NESSEE.**

4 The Mountain Home Department of Veterans Affairs
5 medical center in Johnson City, Tennessee, shall after the
6 date of the enactment of this Act be known and designated
7 as the “James H. Quillen Department of Veterans Affairs
8 Medical Center”.

9 **SEC. 2. REFERENCES.**

10 Any reference in any law, regulation, map, document,
11 record, or other paper of the United States to the medical
12 center referred to in section 1 shall be considered to be
13 a reference to the James H. Quillen Department of Veter-
14 ans Affairs Medical Center.

15 **SEC. 3. EFFECTIVE DATE.**

16 This Act shall take effect at noon on January 3,
17 1997, or the first day on which James H. Quillen other-
18 wise ceases to be a Member of the House of Representa-
19 tives.
