## AN ACT

To direct the President to establish standards and criteria for the provision of major disaster and emergency assistance in response to snow-related events.

1        *Be it enacted by the Senate and House of Representa-*  
2        *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Snow Removal Policy  
3 Act of 1996”.

4 **SEC. 2. FINDINGS.**

5 Congress finds that—

6 (1) winter snow storms in recent years, and  
7 particularly in 1996, have interrupted essential pub-  
8 lic services and utilities, caused widespread disrup-  
9 tion of vital transportation networks, stranded many  
10 motorists, and isolated many homes and businesses;

11 (2) the impact of the winter snow storms was  
12 of such severity and magnitude that effective re-  
13 sponse was beyond the capability of State and local  
14 governments;

15 (3) the policy of the Federal Emergency Man-  
16 agement Agency for providing major disaster and  
17 emergency assistance in response to snow-related  
18 events is unclear; and

19 (4) regulations should be promulgated for pro-  
20 viding major disaster and emergency assistance in  
21 response to snow-related events in order to ensure  
22 the fair treatment of States and local governments  
23 that have incurred costs associated with such a re-  
24 sponse.

1 **SEC. 3. RULEMAKING TO ESTABLISH STANDARDS AND CRI-**  
2 **TERIA FOR SNOW-RELATED EVENTS.**

3 (a) NOTICE OF PROPOSED RULEMAKING.—The  
4 President, acting through the Director of the Federal  
5 Emergency Management Agency, shall issue a notice of  
6 proposed rulemaking to promulgate—

7 (1) standards and criteria for declaring a major  
8 disaster or emergency under the Robert T. Stafford  
9 Disaster Relief and Emergency Assistance Act in re-  
10 sponse to a snow-related event; and

11 (2) standards and criteria for providing assist-  
12 ance under such Act in the case of a snow-related  
13 major disaster or emergency, including reimburse-  
14 ment for snow removal and for debris removal and  
15 emergency protective measures.

16 (b) REQUIREMENT.—Rules to be promulgated under  
17 this section shall ensure that in determining the eligibility  
18 of a State or local government for assistance in connection  
19 with a snow-related event, the President will give consider-  
20 ation to existing capabilities of the State or local govern-  
21 ment.

22 (c) DEADLINES.—The President, acting through the  
23 Director of the Federal Emergency Management Agency,  
24 shall issue—

1           (1) a proposed rule under this section not later  
2           than 3 months after the date of the enactment of  
3           this Act; and

4           (2) a final rule under this section not later than  
5           9 months after such date of enactment.
