## A BILL

To designate 51.7 miles of the Clarion River, located in Pennsylvania, as a component of the National Wild and Scenic Rivers System.

- 1 *Be it enacted by the Senate and House of Representa-*
- 2 *tives of the United States of America in Congress assembled,*
- 3 That section 3(a) of the Wild and Scenic Rivers Act (16

1 U.S.C. 1274(a)) is amended by adding at the end the fol-  
2 lowing new paragraph:

3           “( ) CLARION RIVER, PENNSYLVANIA.—The  
4           51.7-mile segment of the main stem of the Clarion  
5           River from the Allegheny National Forest/State  
6           Game Lands Number 44 boundary, located approxi-  
7           mately 0.7 miles downstream from the Ridgway Bor-  
8           ough limit, to an unnamed tributary in the back-  
9           waters of Piney Dam approximately 0.6 miles down-  
10          stream from Blyson Run, to be administered by the  
11          Secretary of Agriculture in the following classifica-  
12          tions:

13                 “(A) The approximately 8.6-mile segment  
14                 of the main stem from the Allegheny National  
15                 Forest/State Game Lands Number 44 bound-  
16                 ary, located approximately 0.7 miles down-  
17                 stream from the Ridgway Borough limit, to  
18                 Portland Mills, as a recreational river.

19                 “(B) The approximately 8-mile segment of  
20                 the main stem from Portland Mills to the Alle-  
21                 gheny National Forest boundary, located ap-  
22                 proximately 0.8 miles downstream from Irwin  
23                 Run, as a scenic river.

24                 “(C) The approximately 26-mile segment  
25                 of the main stem from the Allegheny National

1 Forest boundary, located approximately 0.8  
2 miles downstream from Irwin Run, to the State  
3 Game Lands 283 boundary, located approxi-  
4 mately 0.9 miles downstream from the  
5 Cooksburg bridge, as a recreational river.

6 “(D) The approximately 9.1-mile segment  
7 of the main stem from the State Game Lands  
8 283 boundary, located approximately 0.9 miles  
9 downstream from the Cooksburg bridge, to an  
10 unnamed tributary at the backwaters of Piney  
11 Dam, located approximately 0.6 miles down-  
12 stream from Blyson Run, as a scenic river.”.
