## AN ACT

To provide for the transfer of public lands to certain  
California Indian Tribes.

1        *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4        This Act may be cited as the “California Indian Land  
5 Transfer Act”.

1 **SEC. 2. LANDS HELD IN TRUST FOR VARIOUS TRIBES OF**  
2 **CALIFORNIA INDIANS.**

3 (a) IN GENERAL.—Subject to section 3, all right,  
4 title, and interest of the United States in and to the lands  
5 described in subsection (b) in connection with each tribe,  
6 band, or group of California Indians listed in such sub-  
7 section (including all improvements on such lands and ap-  
8 purtenances to such lands) are hereby declared to be held  
9 in trust status by the United States for the benefit of such  
10 tribe, band, or group.

11 (b) LANDS DESCRIBED.—The lands described in this  
12 subsection, comprising approximately 1,144.23 acres, and  
13 the related tribe, band, or group, are as follows:

14 (1) PIT RIVER TRIBE.—Lands with respect to  
15 the Pit River Tribe; 560 acres located as follows:  
16 Township 42 North, Range 13 East, Mount Diablo Base  
17 and Meridian

18 Section 3:

19  $S^{1/2}$  of  $NW^{1/4}$ ,  $NW^{1/4}$  of  $NW^{1/4}$ , 120 acres.

20 Township 43 North, Range 13 East

21 Section 1:

22  $N^{1/2}$  of  $NE^{1/4}$ , 80 acres,

16 Lands with respect to the Bridgeport Paiute Indian

17 Colony; 40 acres located as follows:

18 Township 5 North, Range 25 East, Mount Diablo Base

19 and Meridian

20 Section 28:

21 SW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>.

22 (3) UTU UTU GWAITU PAIUTE TRIBE.—Lands

23 with respect to Utu Utu Gwaitu Paiute Tribe, Ben-

24 ton Paiute Reservation; 240 acres located as follows:

1 Township 2 South, Range 31 East, Mount Diablo Base  
2 and Meridian

3 Section 11:

4 SE<sup>1</sup>/<sub>4</sub> and E<sup>1</sup>/<sub>2</sub> of SW<sup>1</sup>/<sub>4</sub>.

5 (4) FORT INDEPENDENCE COMMUNITY OF PAI-  
6 UTE INDIANS.—Lands with respect to the Fort Inde-  
7 pendence Community of Paiute Indians; 200 acres  
8 located as follows:

9 Township 13 South, Range 34 East, Mount Diablo Base  
10 and Meridian

11 Section 1:

12 W<sup>1</sup>/<sub>2</sub> of Lot 5 in the NE<sup>1</sup>/<sub>4</sub>, Lot 3, E<sup>1</sup>/<sub>2</sub> of Lot  
13 4, and E<sup>1</sup>/<sub>2</sub> of Lot 5 in the NW<sup>1</sup>/<sub>4</sub>.

14 (5) BARONA GROUP OF CAPITAN GRANDE BAND  
15 OF MISSION INDIANS.—Lands with respect to the  
16 Barona Group of Capitan Grande Band of Mission  
17 Indians; 5.03 acres located as follows:

18 Township 14 South, Range 2 East, San Bernardino Base  
19 and Meridian

20 Section 7, Lot 15.

21 (6) MORONGO BAND OF MISSION INDIANS.—  
22 Lands with respect to the Morongo Band of Mission  
23 Indians; approximately 40 acres located as follows:

1 Township 3 South, Range 2 East, San Bernardino Base  
2 and Meridian

3 Section 20:

4 NW<sup>1</sup>/<sub>4</sub> of NE<sup>1</sup>/<sub>4</sub>.

5 (7) PALA BAND OF MISSION INDIANS.—Lands  
6 with respect to the Pala Band of Mission Indians;  
7 59.20 acres located as follows:

8 Township 9 South, Range 2 West, San Bernardino Base  
9 and Meridian

10 Section 13, Lot 1, and Section 14, Lots 1, 2, 3.

11 **SEC. 3. EXISTING RIGHTS PRESERVED; MISCELLANEOUS**  
12 **PROVISIONS.**

13 (a) EXISTING RIGHTS PRESERVED.—The declaration  
14 contained in section 2 shall be subject to valid existing  
15 rights in effect on the day before the enactment of this  
16 Act.

17 (b) NOTICE OF CANCELLATION OF GRAZING PRIVI-  
18 LEGES.—Grazing privileges on the lands described in sec-  
19 tion 2 shall terminate two years after the date of enact-  
20 ment of this Act.

21 (c) PROCEEDS FROM RENTS AND ROYALTIES  
22 TRANSFERRED TO INDIANS.—Amounts which accrue to  
23 the United States after the date of the enactment of this  
24 Act from sales, bonuses, royalties, and rentals relating to  
25 any land described in section 2 shall be available for use

1 or obligation, in such manner and for such purposes as  
2 the Assistant Secretary, Indian Affairs, may approve, by  
3 the tribe, band, or group of Indians for whose benefit such  
4 land is held after the date of enactment of this Act.

5 (d) LAWS GOVERNING LANDS TO BE HELD IN  
6 TRUST.—Any lands which are to be held in trust for the  
7 benefit of any tribe, band, or group of Indians pursuant  
8 to this Act shall be added to the existing reservation of  
9 the tribe, band, or group, and the official boundaries of  
10 the reservation shall be modified accordingly. These lands  
11 shall be subject to the laws of the United States relating  
12 to Indian land in the same manner and to the same extent  
13 as other lands held in trust for such tribe, band, or group  
14 on the day before the date of this Act.
