Mr. GALLEGLY introduced the following bill; which was referred to the Committee on Resources

A BILL

To provide for the transfer of public lands to certain California Indian Tribes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “California Indian Land
5 Transfer Act”.

6 **SEC. 2. LANDS HELD IN TRUST FOR VARIOUS TRIBES OF**
7 **CALIFORNIA INDIANS.**

8 (a) IN GENERAL.—Subject to section 3, all right,
9 title, and interest of the United States in and to the lands
10 described in subsection (b) in connection with each tribe,

1 band, or group of California Indians listed in such sub-
 2 section (including all improvements on such lands and ap-
 3 purtenances to such lands) are hereby declared to be held
 4 in trust status by the United States for the benefit of such
 5 tribe, band, or group.

6 (b) LANDS DESCRIBED.—The lands described in this
 7 subsection, comprising approximately 1,144.23 acres, and
 8 the related tribe, band, or group, are as follows:

9 (1) PIT RIVER TRIBE.—Lands with respect to
 10 the Pit River Tribe; 560 acres located as follows:

11 Township 42 North, Range 13 East, Mount Diablo Base
 12 and Meridian

20 ton Paiute Reservation; 240 acres located as follows:

21 Township 2 South, Range 31 East, Mount Diablo Base

22 and Meridian

23 Section 11:

24 SE¹/₄ and E¹/₂ of SW¹/₄.

1 (d) LAWS GOVERNING LANDS TO BE HELD IN
2 TRUST.—Any lands which are to be held in trust for the
3 benefit of any tribe, band, or group of Indians pursuant
4 to this Act shall be added to the existing reservation of
5 the tribe, band, or group, and the official boundaries of
6 the reservation shall be modified accordingly. These lands
7 shall be subject to the laws of the United States relating
8 to Indian land in the same manner and to the same extent
9 as other lands held in trust for such tribe, band, or group
10 on the day before the date of this Act.
