A BILL

To amend the international narcotics control program under the Foreign Assistance Act of 1961 to establish an additional certification standard for certain illicit drug producing countries and drug-transit countries and to establish an additional reporting requirement under that program.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. CERTIFICATION PROCEDURES FOR INTER-**
2 **NATIONAL NARCOTICS CONTROL.**

3 Subparagraph (A) of section 490(b)(1) of the Foreign
4 Assistance Act of 1961 (22 U.S.C. 2291j(b)(1)(A)) is
5 amended to read as follows:

6 “(A)(i) during the previous year the coun-
7 try has cooperated fully with the United States,
8 or has taken adequate steps on its own, to
9 achieve full compliance with the goals and ob-
10 jectives established by the United Nations Con-
11 vention Against Illicit Traffic in Narcotic Drugs
12 and Psychotropic Substances; or

13 “(ii) with respect to the requirement to
14 vote against multilateral development bank as-
15 sistance pursuant to subsection (a)(2), during
16 the previous year the country has taken sub-
17 stantial steps, but has been unable, to fully co-
18 operate with the United States, or has taken
19 substantial, but inadequate, steps on its own, to
20 achieve full compliance with the goals and ob-
21 jectives established by the United Nations Con-
22 vention Against Illicit Traffic in Narcotic Drugs
23 and Psychotropic Substances; or”.

1 **SEC. 2. ADDITIONAL INTERNATIONAL NARCOTICS CON-**
2 **TROL REPORTING REQUIREMENT.**

3 Section 489 of the Foreign Assistance Act of 1961
4 (22 U.S.C. 2291h) is amended by adding at the end the
5 following:

6 “(c) ANNUAL REPORTS ON CERTIFICATION
7 GOALS.—Not later than June 1 of each year, the Sec-
8 retary of State, in consultation with appropriate United
9 States Government agencies, shall report to the appro-
10 priate committees of the Congress on the list of objectives,
11 as agreed to by the United States Government and each
12 major illicit drug producing country and major drug-tran-
13 sit country, that each of those countries must meet for
14 the current calendar year for purposes of certifying each
15 such country pursuant to section 490(b), or for recertify-
16 ing each such country pursuant to section 490(f), as the
17 case may be.”.
