Mr. BURGESS, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

# RESOLUTION

Providing for consideration of the bill (H.R. 3189) to prohibit the conditioning of any permit, lease, or other use agreement on the transfer, relinquishment, or other impairment of any water right to the United States by the Secretaries of the Interior and Agriculture; providing for consideration of the bill (H.R. 4015) to amend title XVIII of the Social Security Act to repeal the Medicare sustainable growth rate and improve Medicare payments

for physicians and other professionals, and for other purposes; and providing for proceedings during the period from March 17, 2014, through March 21, 2014.

1       *Resolved*, That at any time after adoption of this reso-  
2 lution the Speaker may, pursuant to clause 2(b) of rule  
3 XVIII, declare the House resolved into the Committee of  
4 the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 3189) to prohibit the conditioning  
6 of any permit, lease, or other use agreement on the trans-  
7 fer, relinquishment, or other impairment of any water  
8 right to the United States by the Secretaries of the Inte-  
9 rior and Agriculture. The first reading of the bill shall be  
10 dispensed with. All points of order against consideration  
11 of the bill are waived. General debate shall be confined  
12 to the bill and shall not exceed one hour equally divided  
13 and controlled by the chair and ranking minority member  
14 of the Committee on Natural Resources. After general de-  
15 bate the bill shall be considered for amendment under the  
16 five-minute rule. It shall be in order to consider as an  
17 original bill for the purpose of amendment under the five-  
18 minute rule the amendment in the nature of a substitute  
19 recommended by the Committee on Natural Resources  
20 now printed in the bill. The committee amendment in the  
21 nature of a substitute shall be considered as read. All  
22 points of order against the committee amendment in the  
23 nature of a substitute are waived. No amendment to the

1 committee amendment in the nature of a substitute shall  
2 be in order except those printed in part A of the report  
3 of the Committee on Rules accompanying this resolution.  
4 Each such amendment may be offered only in the order  
5 printed in the report, may be offered only by a Member  
6 designated in the report, shall be considered as read, shall  
7 be debatable for the time specified in the report equally  
8 divided and controlled by the proponent and an opponent,  
9 shall not be subject to amendment, and shall not be sub-  
10 ject to a demand for division of the question in the House  
11 or in the Committee of the Whole. All points of order  
12 against such amendments are waived. At the conclusion  
13 of consideration of the bill for amendment the Committee  
14 shall rise and report the bill to the House with such  
15 amendments as may have been adopted. Any Member may  
16 demand a separate vote in the House on any amendment  
17 adopted in the Committee of the Whole to the bill or to  
18 the committee amendment in the nature of a substitute.  
19 The previous question shall be considered as ordered on  
20 the bill and amendments thereto to final passage without  
21 intervening motion except one motion to recommit with  
22 or without instructions.

23       SEC. 2. Upon adoption of this resolution it shall be  
24 in order to consider in the House the bill (H.R. 4015)  
25 to amend title XVIII of the Social Security Act to repeal

1 the Medicare sustainable growth rate and improve Medi-  
2 care payments for physicians and other professionals, and  
3 for other purposes. All points of order against consider-  
4 ation of the bill are waived. The amendment printed in  
5 part B of the report of the Committee on Rules accom-  
6 panying this resolution shall be considered as adopted.  
7 The bill, as amended, shall be considered as read. All  
8 points of order against provisions in the bill, as amended,  
9 are waived. The previous question shall be considered as  
10 ordered on the bill, as amended, and on any amendment  
11 thereto to final passage without intervening motion except:  
12 (1) one hour of debate equally divided among and con-  
13 trolled by the chair and ranking minority member of the  
14 Committee on Energy and Commerce and the chair and  
15 ranking minority member of the Committee on Ways and  
16 Means; and (2) one motion to recommit with or without  
17 instructions.

18       SEC. 3. On any legislative day during the period from  
19 March 17, 2014, through March 21, 2014—

20       (a) the Journal of the proceedings of the previous day  
21 shall be considered as approved; and

22       (b) the Chair may at any time declare the House ad-  
23 journed to meet at a date and time, within the limits of  
24 clause 4, section 5, article I of the Constitution, to be an-  
25 nounced by the Chair in declaring the adjournment.

1        SEC. 4. The Speaker may appoint Members to per-  
2 form the duties of the Chair for the duration of the period  
3 addressed by section 3 of this resolution as though under  
4 clause 8(a) of rule I.
