## RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 124) making continuing appropriations for fiscal year 2015, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the joint resolu-  
3 tion (H.J. Res. 124) making continuing appropriations for  
4 fiscal year 2015, and for other purposes. All points of  
5 order against consideration of the joint resolution are  
6 waived. The amendment printed in part A of the report  
7 of the Committee on Rules accompanying this resolution

1 shall be considered as adopted. The joint resolution, as  
2 amended, shall be considered as read. All points of order  
3 against provisions in the joint resolution, as amended, are  
4 waived. The previous question shall be considered as or-  
5 dered on the joint resolution, as amended, and on any fur-  
6 ther amendment thereto to final passage without inter-  
7 vening motion except: (1) one hour of debate equally di-  
8 vided and controlled by the chair and ranking minority  
9 member of the Committee on Appropriations; (2) the fur-  
10 ther amendment printed in part B of the report of the  
11 Committee on Rules, if offered by Representative McKeon  
12 of California or his designee, which shall be in order with-  
13 out intervention of any point of order, shall be considered  
14 as read, shall be separately debatable for six hours equally  
15 divided and controlled by Representative McKeon of Cali-  
16 fornia and Representative Smith of Washington or their  
17 respective designees, and shall not be subject to a demand  
18 for division of the question; and (3) one motion to recom-  
19 mit with or without instructions.

20 SEC. 2. Section 4(c) of House Resolution 567 is  
21 amended by adding the following new paragraph:

22 “(7) The provisions of paragraphs (f)(1)  
23 through (f)(12) of clause 4 of rule XI shall be con-  
24 sidered to be written rules adopted by the Select  
25 Committee as though pursuant to such clause.”.
