A BILL

To reauthorize the United States Commission on Civil Rights, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Civil Rights Commis-
5 sion Act of 1996”.

1 **SEC. 2. EXTENSION AND AUTHORIZATION OF APPROPRIA-**
2 **TIONS.**

3 (a) EXTENSION.—Section 6 of the Civil Rights Com-
4 mission Act of ~~1986~~ 1983 (42 U.S.C. 1975d) is amended
5 by striking “1996” and inserting “1997”.

6 (b) AUTHORIZATION.—(1) The first sentence of sec-
7 tion 5 of the Civil Rights Commission Act of 1983 (42
8 U.S.C. 1975c) is amended to read “There are authorized
9 to be appropriated to carry out this Act \$8,750,000 for
10 fiscal year 1997.”.

11 (2) The second sentence of section 5 of the Civil
12 Rights Commission Act of 1983 (42 U.S.C. 1975c) is
13 amended by striking “1995” and inserting “1997”.

14 **SEC. 3. SUBPOENAS.**

15 Section 3(e)(2) of the Civil Rights Act of 1983 (42
16 U.S.C. 1975a) is amended by inserting “, by a majority
17 vote of those present and voting” before “issue subpoe-
18 nas”.

19 **SEC. 4. STAFF DIRECTOR.**

20 Section 4(a) of the Civil Rights Commission Act of
21 1983 (42 U.S.C. 1975b(a)) is amended by adding at the
22 end the following:

23 “(3) REMOVAL OF STAFF DIRECTOR.—The
24 Commission may, by a majority vote of the Commis-
25 sion, remove the staff director from office.”.

1 **SEC. 5. APPLICATION OF FREEDOM OF INFORMATION, PRI-**
2 **VACY, AND SUNSHINE ACTS.**

3 Section 4 of the Civil Rights Commission Act of 1983
4 (42 U.S.C. 1975b) is amended by adding at the end the
5 following:

6 “(f) APPLICATION OF CERTAIN PROVISIONS OF
7 LAW.—The Commission shall be included in the term
8 ~~“agency”~~ ‘*agency*’ as such term is defined for the purposes
9 of sections 552, 552a, and 552b of title 5, United States
10 Code.”.
