A BILL

To suspend temporarily the duty on certain chemicals used in the formulation of an HIV Protease Inhibitor.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. TEMPORARY DUTY SUSPENSION.**

4 (a) IN GENERAL.—Subchapter II of Chapter 99 of
5 the Harmonized Tariff Schedule of the United States is
6 amended by inserting in numerical sequence the following
7 new headings:

1 (b) EFFECTIVE DATE.—

2 (1) IN GENERAL.—The amendment made by
3 subsection (a) applies with respect to goods entered
4 or withdrawn from warehouse for consumption, on
5 or after the 15th day after the date of the enact-
6 ment of this Act.

7 (2) RETROACTIVE APPLICATION TO CERTAIN
8 ENTRIES.—Notwithstanding section 514 of the Tar-
9 iff Act of 1930 (19 U.S.C. 1514) or any other provi-
10 sion of law, upon proper request filed with the Cus-
11 toms Service before the 90th day after the date of
12 the enactment of this Act, any entry, or withdrawal
13 from warehouse for consumption, of any goods de-
14 scribed in subheading 9902.32.12, 9902.32.13, or
15 9902.32.14 of the Harmonized Tariff Schedule of
16 the United States (as amended by subsection (a))
17 that was made—

18 (A) on or after August 1, 1996, and

19 (B) before the 15th day after the date of
20 the enactment of this Act,

1 shall be liquidated or reliquidated as though such
2 entry or withdrawal occurred on the 15th day after
3 the date of the enactment of this Act.
