## A BILL

To protect the voting rights of homeless citizens.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Voting Rights of  
5 Homeless Citizens Act of 1995”.

6 **SEC. 2. VOTING RIGHTS OF HOMELESS CITIZENS.**

7 No voting qualification or prerequisite to voting, or  
8 standard, practice, or procedure shall be imposed or ap-  
9 plied by any State or political subdivision to deny or  
10 abridge the right of any citizen of the United States to

1 vote because that citizen resides at or in a nontraditional  
2 abode.

3 **SEC. 3. ENFORCEMENT.**

4 The Attorney General may commence in the name of  
5 the United States a civil action (including an action  
6 against a State or political subdivision) or an aggrieved  
7 citizen may institute a proceeding under this Act, for in-  
8 junctive relief against a violation of section 2.

9 **SEC. 4. RELATIONSHIP TO VOTING RIGHTS ACT OF 1965.**

10 This Act shall not be construed to impair any right  
11 guaranteed by the Voting Rights Act of 1965 (42 U.S.C.  
12 1973 et seq.).

13 **SEC. 5. DEFINITIONS.**

14 As used in this Act, the term “nontraditional abode”  
15 includes—

16 (1) a supervised publicly or privately operated  
17 shelter designed to provide temporary living accom-  
18 modations (including welfare hotels, congregate shel-  
19 ters, and transitional housing for the mentally ill);  
20 and

21 (2) a public or private place not designated for,  
22 or ordinarily used as, regular sleeping accommoda-  
23 tion for human beings.

1 **SEC. 6. EFFECTIVE DATE.**

2       This Act applies with respect to elections taking place  
3 after December 31, 1995.
