## A BILL

To provide off-budget treatment for the Highway Trust Fund, the Airport and Airway Trust Fund, the Inland Waterways Trust Fund, and the Harbor Maintenance Trust Fund.

1        *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3        **SECTION 1. SHORT TITLE.**

4        *This Act may be cited as the “Truth in Budgeting*  
 5 *Act”.*

6        **SEC. 2. BUDGETARY TREATMENT OF HIGHWAY TRUST**

7                                **FUND, AIRPORT AND AIRWAY TRUST FUND,**

8                                **INLAND WATERWAYS TRUST FUND, AND HAR-**

9                                **BOR MAINTENANCE TRUST FUND.**

10        *Notwithstanding any other provision of law, the re-*  
 11 *ceipts and disbursements of the Highway Trust Fund, the*  
 12 *Airport and Airway Trust Fund, the Inland Waterways*  
 13 *Trust Fund, and the Harbor Maintenance Trust Fund—*

1           (1) *shall not be counted as new budget authority,*  
2 *outlays, receipts, or deficit or surplus for purposes*  
3 *of—*

4                   (A) *the budget of the United States Govern-*  
5 *ment as submitted by the President,*

6                   (B) *the congressional budget (including al-*  
7 *locations of budget authority and outlays pro-*  
8 *vided therein), or*

9                   (C) *the Balanced Budget and Emergency*  
10 *Deficit Control Act of 1985; and*

11           (2) *shall be exempt from any general budget lim-*  
12 *itation imposed by statute on expenditures and net*  
13 *lending (budget outlays) of the United States Govern-*  
14 *ment.*

15 **SEC. 3. SAFEGUARDS AGAINST DEFICIT SPENDING OUT OF**  
16 **AIRPORT AND AIRWAY TRUST FUND.**

17           (a) *IN GENERAL.*—Chapter 471 of title 49, United  
18 *States Code, is amended—*

19                   (1) *by redesignating section 47131 as section*  
20 *47132; and*

21                   (2) *by inserting after section 47130 the following*  
22 *new section:*

23 **“§ 47131. Safeguards against deficit spending**

24           “(a) *ESTIMATES OF UNFUNDED AVIATION AUTHOR-*  
25 *IZATIONS AND NET AVIATION RECEIPTS.*—Not later than

1 *March 31 of each year, the Secretary, in consultation with*  
2 *the Secretary of the Treasury, shall estimate—*

3           “(1) *the amount which would (but for this sec-*  
4 *tion) be the unfunded aviation authorizations at the*  
5 *close of the first fiscal year that begins after that*  
6 *Mach 31, and*

7           “(2) *the net aviation receipts at the close of such*  
8 *fiscal year.*

9           “(b) *PROCEDURE IF EXCESS UNFUNDED AVIATION*  
10 *AUTHORIZATIONS.—If the Secretary determines for any fis-*  
11 *cal year that the amount described in subsection (a)(1) ex-*  
12 *ceeds the amount described in subsection (a)(2), the Sec-*  
13 *retary shall determine the amount of such excess.*

14           “(c) *ADJUSTMENT OF AUTHORIZATIONS IF UNFUNDED*  
15 *AUTHORIZATIONS EXCEED RECEIPTS.—*

16           “(1) *DETERMINATION OF PERCENTAGE.—If the*  
17 *Secretary determines that there is an excess referred*  
18 *to in subsection (b) for a fiscal year, the Secretary*  
19 *shall determine the percentage which—*

20                   “(A) *such excess, is of*

21                   “(B) *the total of the amounts authorized to*  
22 *be appropriated from the Airport and Airway*  
23 *Trust Fund for the next fiscal year.*

24           “(2) *ADJUSTMENT OF AUTHORIZATIONS.—If the*  
25 *Secretary determines a percentage under paragraph*

1       (1), each amount authorized to be appropriated from  
2       the Airport and Airway Trust Fund for the next fis-  
3       cal year shall be reduced by such percentage.

4       “(d) AVAILABILITY OF AMOUNTS PREVIOUSLY WITH-  
5 HELD.—

6               “(1) ADJUSTMENT OF AUTHORIZATIONS.—If,  
7       after a reduction has been made under subsection  
8       (c)(2), the Secretary determines that the amount de-  
9       scribed in subsection (a)(1) does not exceed the  
10       amount described in subsection (a)(2) or that the ex-  
11       cess referred to in subsection (b) is less than the  
12       amount previously determined, each amount author-  
13       ized to be appropriated that was reduced under sub-  
14       section (c)(2) shall be increased, by an equal percent-  
15       age, to the extent the Secretary determines that it  
16       may be so increased without causing the amount de-  
17       scribed in subsection (a)(1) to exceed the amount de-  
18       scribed in subsection (a)(2) (but not by more than the  
19       amount of the reduction).

20               “(2) APPORTIONMENT.—The Secretary shall ap-  
21       portion amounts made available for apportionment  
22       by paragraph (1).

23               “(3) PERIOD OF AVAILABILITY.—Any funds ap-  
24       portioned under paragraph (2) shall remain available  
25       for the period for which they would be available if

1        *such apportionment took effect with the fiscal year in*  
2        *which they are apportioned under paragraph (2).*

3        *“(e) REPORTS.—Any estimate under subsection (a)*  
4        *and any determination under subsection (b), (c), or (d)*  
5        *shall be reported by the Secretary to Congress.*

6        *“(f) DEFINITIONS.—For purposes of this section, the*  
7        *following definitions apply:*

8                *“(1) NET AVIATION RECEIPTS.—The term ‘net*  
9                *aviation receipts’ means, with respect to any period,*  
10               *the excess of—*

11                        *“(A) the receipts (including interest) of the*  
12                        *Airport and Airway Trust Fund during such pe-*  
13                        *riod, over*

14                        *“(B) the amounts to be transferred during*  
15                        *such period from the Airport and Airway Trust*  
16                        *Fund under section 9502(d) of the Internal Reve-*  
17                         *nue Code of 1986 (other than paragraph (1)*  
18                        *thereof).*

19                *“(2) UNFUNDED AVIATION AUTHORIZATIONS.—*  
20                *The term ‘unfunded aviation authorization’ means, at*  
21                *any time, the excess (if any) of—*

22                        *“(A) the total amount authorized to be ap-*  
23                        *propriated from the Airport and Airway Trust*  
24                        *Fund which has not been appropriated, over*



1           (2) *the net inland waterways receipts and net*  
2           *harbor maintenance receipts at the close of such fiscal*  
3           *year.*

4           **(b) PROCEDURE IF EXCESS UNFUNDED INLAND WA-**  
5           **TERWAYS AUTHORIZATIONS.**—*If the Secretary of the Army*  
6           *determines with respect to the Inland Waterways Trust*  
7           *Fund or the Harbor Maintenance Trust Fund for any fiscal*  
8           *year that the amount described in subsection (a)(1) exceeds*  
9           *the amount described in subsection (a)(2), the Secretary*  
10          *shall determine the amount of such excess.*

11          **(c) ADJUSTMENT OF AUTHORIZATIONS IF UNFUNDED**  
12          **AUTHORIZATIONS EXCEED RECEIPTS.**—

13                 **(1) DETERMINATION OF PERCENTAGE.**—*If the*  
14                 *Secretary of the Army determines that there is an ex-*  
15                 *cess referred to in subsection (b) for a fiscal year, the*  
16                 *Secretary of the Army shall determine the percentage*  
17                 *which—*

18                         **(A)** *such excess, is of*

19                         **(B)** *the total of the amounts authorized to*  
20                         *be appropriated from the Inland Waterways*  
21                         *Trust Fund or the Harbor Maintenance Trust*  
22                         *Fund, as the case may be, for the next fiscal*  
23                         *year.*

24                 **(2) ADJUSTMENT OF AUTHORIZATIONS.**—*If the*  
25                 *Secretary of the Army determines a percentage under*

1        *paragraph (1), each amount authorized to be appro-*  
2        *priated from the Trust Fund for the next fiscal year*  
3        *shall be reduced by such percentage.*

4        *(d) AVAILABILITY OF AMOUNTS PREVIOUSLY WITH-*  
5        *HELD.—If, after an adjustment has been made under sub-*  
6        *section (c)(2), the Secretary of the Army determines with*  
7        *respect to the Inland Waterways Trust Fund or the Harbor*  
8        *Maintenance Trust Fund that the amount described in sub-*  
9        *section (a)(1) does not exceed the amount described in sub-*  
10       *section (a)(2) or that the excess referred to in subsection*  
11       *(b) with respect to the Trust Fund is less than the amount*  
12       *previously determined, each amount authorized to be appro-*  
13       *priated that was reduced under subsection (c)(2) with re-*  
14       *spect to the Trust Fund shall be increased, by an equal per-*  
15       *centage, to the extent the Secretary of the Army determines*  
16       *that it may be so increased without causing the amount*  
17       *described in subsection (a)(1) to exceed with respect to the*  
18       *Trust Fund the amount described in subsection (a)(2) (but*  
19       *not by more than the amount of the reduction).*

20       *(e) REPORTS.—Any estimate under subsection (a) and*  
21       *any determination under subsection (b), (c), or (d) shall*  
22       *be reported by the Secretary of the Army to Congress.*

23       *(f) DEFINITIONS.—For purposes of this section the fol-*  
24       *lowing definitions apply:*

1           (1) *AIRPORT AND AIRWAY TRUST FUND.*—The  
2 term “*Airport and Airway Trust Fund*” means the  
3 *Airport and Airway Trust Fund* established by sec-  
4 *tion 9502 of the Internal Revenue Code of 1986.*

5           (2) *HARBOR MAINTENANCE TRUST FUND.*—The  
6 term “*Harbor Maintenance Trust Fund*” means the  
7 *Harbor Maintenance Trust Fund* established by sec-  
8 *tion 9505 of the Internal Revenue Code of 1986.*

9           (3) *HIGHWAY TRUST FUND.*—The term “*High-*  
10 *way Trust Fund*” means the *Highway Trust Fund* es-  
11 *tablished by section 9503 of the Internal Revenue*  
12 *Code of 1986.*

13           (4) *INLAND WATERWAYS TRUST FUND.*—The  
14 term “*Inland Waterways Trust Fund*” means the *In-*  
15 *land Waterways Trust Fund* established by section  
16 *9506 of the Internal Revenue Code of 1986.*

17           (5) *NET HARBOR MAINTENANCE RECEIPTS.*—The  
18 term “*net harbor maintenance receipts*” means, with  
19 *respect to any period, the receipts (including interest)*  
20 *of the Harbor Maintenance Trust Fund during such*  
21 *period.*

22           (6) *NET INLAND WATERWAYS RECEIPTS.*—The  
23 term “*net inland waterways receipts*” means, with re-  
24 *spect to any period, the receipts (including interest)*

1       *of the Inland Waterways Trust Fund during such pe-*  
2       *riod.*

3               (7) *UNFUNDED INLAND WATERWAYS AUTHORIZA-*  
4       *TIONS.—The term “unfunded inland waterways au-*  
5       *thorizations” means, at any time, the excess (if any)*  
6       *of—*

7                       (A) *the total amount authorized to be ap-*  
8       *propriated from the Inland Waterways Trust*  
9       *Fund which has not been appropriated, over*

10                      (B) *the amount available in the Inland Wa-*  
11       *terways Trust Fund at such time to make such*  
12       *appropriations.*

13               (8) *UNFUNDED HARBOR MAINTENANCE AUTHOR-*  
14       *IZATIONS.—The term “unfunded harbor maintenance*  
15       *authorizations” means, at any time, the excess (if*  
16       *any) of—*

17                      (A) *the total amount authorized to be ap-*  
18       *propriated from the Harbor Maintenance Trust*  
19       *Fund which has not been appropriated, over*

20                      (B) *the amount available in the Harbor*  
21       *Maintenance Trust Fund at such time to make*  
22       *such appropriations.*

1 **SEC. 5. APPLICABILITY.**

2       *This Act (including the amendments made by this Act)*  
3 *shall apply to fiscal years beginning after September 30,*  
4 *1995.*
