Mrs. WALDHOLTZ, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for the consideration of the bill (H.R. 925) to compensate owners of private property for the effect of certain regulatory restrictions.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 925) to compensate owners of pri-  
6 vate property for the effect of certain regulatory restric-  
7 tions. The first reading of the bill shall be dispensed with.

1 Points of order against consideration of the bill for failure  
2 to comply with section 302(f), 308(a), 311(a), or 401(b)  
3 of the Congressional Budget Act of 1974 are waived. Gen-  
4 eral debate shall be confined to the bill and the amend-  
5 ment recommended by the Committee on the Judiciary  
6 and shall not exceed one hour equally divided and con-  
7 trolled by the chairman and ranking minority member of  
8 the Committee on the Judiciary. After general debate the  
9 bill shall be considered for amendment under the five-  
10 minute rule for a period not to exceed twelve hours. It  
11 shall be in order to consider as an original bill for the  
12 purpose of amendment under the five-minute rule the  
13 amendment in the nature of a substitute recommended by  
14 the Committee on the Judiciary now printed in the bill.  
15 The committee amendment in the nature of a substitute  
16 shall be considered as read. Points of order against the  
17 committee amendment in the nature of a substitute for  
18 failure to comply with clause 7 of rule XVI, clause 5(a)  
19 of rule XXI, or section 302(f), 311(a), or 401(b) of the  
20 Congressional Budget Act of 1974 are waived. No amend-  
21 ment to the committee amendment in the nature of a sub-  
22 stitute shall be in order unless printed in the portion of  
23 the Congressional Record designated for that purpose in  
24 clause 6 of rule XXIII before the beginning of consider-  
25 ation of the bill for amendment. Amendments so printed

1 shall be considered as read. Points of order against the  
2 amendment specified in the report of the Committee on  
3 Rules accompanying this resolution to be offered by Rep-  
4 resentative Canady of Florida or a designee for failure to  
5 comply with clause 5(a) of rule XXI are waived. Pending  
6 the consideration of that amendment and before the con-  
7 sideration of any other amendment, it shall be in order  
8 to consider the amendment thereto specified in the report  
9 of the Committee on Rules to be offered by Representative  
10 Tauzin of Louisiana or a designee. At the conclusion of  
11 consideration of the bill for amendment the Committee  
12 shall rise and report the bill to the House with such  
13 amendments as may have been adopted. Any Member may  
14 demand a separate vote in the House on any amendment  
15 adopted in the Committee of the Whole to the bill or to  
16 the committee amendment in the nature of a substitute.  
17 The previous question shall be considered as ordered on  
18 the bill and amendments thereto to final passage without  
19 intervening motion except one motion to recommit with  
20 or without instructions.

21       SEC. 2. After passage of H.R. 925, it shall be in order  
22 to consider in the House the bill (H.R. 9) to create jobs,  
23 enhance wages, strengthen property rights, maintain cer-  
24 tain economic liberties, decentralize and reduce the power  
25 of the Federal Government with respect to the States, lo-

1 calities, and citizens of the United States, and to increase  
2 the accountability of Federal officials. All points of order  
3 against the bill and against its consideration are waived.  
4 It shall be in order to move to strike all after section 1  
5 of the bill and insert a text composed of four divisions  
6 as follows: (1) division A, consisting of the text of H.R.  
7 830, as passed by the House; (2) division B, consisting  
8 of the text of H.R. 925, as passed by the House; (3) divi-  
9 sion C, consisting of the text of H.R. 926, as passed by  
10 the House; and (4) division D, consisting of the text of  
11 H.R. 1022, as passed by the House. All points of order  
12 against that motion are waived. The previous question  
13 shall be considered as ordered on the motion to amend  
14 and on the bill to final passage without intervening motion  
15 except one motion to recommit with or without instruc-  
16 tions.
