RESOLUTION

Providing amounts for the expenses of certain committees of the House of Representatives in the One Hundred Fourth Congress.

1 *Resolved,*

1 **SECTION 1. COMMITTEE EXPENSES FOR THE ONE HUN-**
2 **DRED FOURTH CONGRESS.**

3 (a) *IN GENERAL.*—With respect to the One Hundred
4 Fourth Congress, there shall be paid out of the applicable
5 accounts of the House of Representatives, in accordance
6 with this primary expense resolution, not more than the
7 amount specified in subsection (b) for the expenses of each
8 committee named in that subsection, including—

9 (1) *the expenses of all staff salaries;*

10 (2) *the expenses of consultant services under sec-*
11 *tion 202(i) of the Legislative Reorganization Act of*
12 *1946 (2 U.S.C. 72a(i)); and*

13 (3) *the expenses of staff training under section*
14 *202(j) of such Act (2 U.S.C. 72a(j)).*

15 (b) *COMMITTEES AND AMOUNTS.*—The committees and

3 **SEC. 5. REGULATIONS.**

4 *Amounts made available under this resolution shall be*
5 *expended in accordance with regulations prescribed by the*
6 *Committee on House Oversight.*

7 **SEC. 6. ADJUSTMENT AUTHORITY.**

8 *The Committee on House Oversight shall have author-*
9 *ity to make adjustments in amounts under section 1, if nec-*
10 *essary to comply with an order of the President issued*
11 *under section 254 of the Balanced Budget and Emergency*
12 *Deficit Control Act of 1985 or to conform to any reduction*
13 *in appropriations for the purposes of such section 1.*
