Mr. QUILLEN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 1817) making appropriations for military construction for the Department of Defense for the fiscal year ending September 30, 1996, and for other purposes.

1 *Resolved*, That at any time after the adoption of this
2 resolution the Speaker may, pursuant to clause 1(b) of
3 rule XXIII, declare the House resolved into the Committee
4 of the Whole House on the state of the Union for consider-
5 ation of the bill (H.R. 1817) making appropriations for
6 military construction for the Department of Defense for

1 the fiscal year ending September 30, 1996, and for other
2 purposes. The first reading of the bill shall be dispensed
3 with. General debate shall be confined to the bill and shall
4 not exceed one hour equally divided and controlled by the
5 chairman and ranking minority member of the Committee
6 on Appropriations. After general debate the bill shall be
7 considered for amendment under the five-minute rule.
8 Points of order against provisions in the bill for failure
9 to comply with clause 2 or 6 of rule XXI are waived. Dur-
10 ing consideration of the bill for amendment, the Chairman
11 of the Committee of the Whole may accord priority in rec-
12 ognition on the basis of whether the Member offering an
13 amendment has caused it to be printed in the portion of
14 the Congressional Record designated for that purpose in
15 clause 6 of rule XXIII. Amendments so printed shall be
16 considered as read. At the conclusion of consideration of
17 the bill for amendment the Committee shall rise and re-
18 port the bill to the House with such amendments as may
19 have been adopted. The previous question shall be consid-
20 ered as ordered on the bill and amendments thereto to
21 final passage without intervening motion except one mo-
22 tion to recommit.

23 SEC. 2. (a) For purposes of sections 302 and 311
24 of the Congressional Budget Act of 1974 as they apply
25 in the House of Representatives to the Committee on Ap-

1 appropriations and to the consideration of general appropria-
2 tion bills, amendments thereto, or conference reports
3 thereon, the Congress shall be considered to have adopted
4 House Concurrent Resolution 67 in the form adopted by
5 the House on May 18, 1995.

6 (b) The allocations of spending and credit responsibil-
7 ities to the Committee on Appropriations that are depicted
8 in House Report 104-120, beginning on page 144, shall
9 be considered as the allocations otherwise required by sec-
10 tion 602(a) of that Act to be included in the joint explana-
11 tory statement of the managers on a conference report to
12 accompany a concurrent resolution on the budget.

13 (c) This section shall cease to apply upon final adop-
14 tion by the House and the Senate of a concurrent resolu-
15 tion on the budget for fiscal year 1996.
