## RESOLUTION

Amending clause 4 of rule XIII of the Rules of the House to abolish the Consent Calendar and to establish in its place a Corrections Calendar.

1       *Resolved*, That clause 4 of rule XIII of the Rules of  
2 the House of Representatives is amended to read as fol-  
3 lows:

4       “4. (a) After a bill has been favorably reported and  
5 placed on either the Union or House Calendar, the Speak-  
6 er may, after consultation with the Minority Leader, file  
7 with the Clerk a notice requesting that such bill also be  
8 placed upon a special calendar to be known as the “Cor-  
9 rections Calendar”. On the second and fourth Tuesdays  
10 of each month, after the Pledge of Allegiance, the Speaker  
11 may direct the Clerk to call the bills in numerical order  
12 which have been on the Corrections Calendar for three leg-  
13 islative days.

14       “(b) A bill so called shall be considered in the House,  
15 debatable for one hour equally divided and controlled by  
16 the chairman and ranking minority member of the pri-  
17 mary committee of jurisdiction reporting the bill, shall not  
18 be subject to amendment except those amendments rec-  
19 ommended by the primary committee of jurisdiction or  
20 those offered by the chairman of the primary committee,  
21 and the previous question shall be considered as ordered  
22 on the bill and any amendment thereto to final passage  
23 without intervening motion except one motion to recommit  
24 with or without instructions.

1       “(c) A three-fifths vote of the members voting shall  
2 be required to pass any bill called from the Corrections  
3 Calendar but the rejection of any such bill, or the sustain-  
4 ing of any point of order against it or its consideration,  
5 shall not cause it to be removed from the Calendar to  
6 which it was originally referred.”.
