Mr. SOLOMON, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2606) to prohibit the use of funds appropriated to the Department of Defense from being used for the deployment on the ground of United States Armed Forces in the Republic of Bosnia and Herzegovina as part of any peacekeeping operation, or as part of any implementation force, unless funds for such deployment are specifically appropriated by law.

1 *Resolved*, That upon the adoption of this resolution
2 it shall be in order without intervention of any point of
3 order to consider in the House the bill (H.R. 2606) to
4 prohibit the use of funds appropriated to the Department
5 of Defense from being used for the deployment on the
6 ground of United States Armed Forces in the Republic
7 of Bosnia and Herzegovina as part of any peacekeeping
8 operation, or as part of any implementation force, unless
9 funds for such deployment are specifically appropriated by
10 law. The previous question shall be considered as ordered
11 on the bill and any amendment thereto to final passage
12 without intervening motion except: (1) one hour of debate
13 on the bill, which shall be equally divided and controlled
14 by the chairman and ranking minority member of the
15 Committee on National Security; (2) one motion to amend
16 by the minority leader or his designee, which shall be con-
17 sidered as read, and shall be separately debatable for one
18 hour equally divided and controlled by the proponent and
19 an opponent; and (3) one motion to recommit, which may
20 include instructions only if offered by the minority leader
21 or his designee.

22 SEC. 2. Notwithstanding any other provision of this
23 resolution, if the minority leader or his designee an-
24 nounces that an amendment will not be offered, there shall
25 be an additional period of one hour of debate equally di-

- 1 vided and controlled by the chairman and ranking minor-
- 2 ity member of the Committee on National Security.
