6 clared pursuant to this subsection may not extend beyond
7 the calendar day of Friday, January 12, 1996.

8 (c) The Speaker may declare recesses subject to the
9 call of the Chair on the calendar days of Friday, January
10 12, 1996, through Tuesday, January 16, 1996. A recess
11 declared pursuant to this subsection may not extend be-
12 yond the calendar day of Tuesday, January 16, 1996.

13 (d) The Speaker may declare recesses subject to the
14 call of the Chair on the calendar days of Tuesday, January
15 16, 1996, through Friday, January 19, 1996. A recess de-
16 clared pursuant to this subsection may not extend beyond
17 the calendar day of Friday, January 19, 1996.

18 (e) The Speaker may declare recesses subject to the
19 call of the Chair on the calendar days of Friday, January
20 19, 1996, through Tuesday, January 23, 1996. A recess
21 declared pursuant to this subsection may not extend be-
22 yond the calendar day of Tuesday, January 23, 1996.

23 SEC. 2. The requirement of clause 4(b) of rule XI
24 for a two-thirds vote to consider a report from the Com-
25 mittee on Rules on the same day it is presented to the

1 House is waived with respect to any resolution reported
2 from that committee before the calendar day of Wednes-
3 day, January 24, 1996, and providing for consideration
4 or disposition of any of the following measures:

5 (1) A bill making general appropriations for the
6 fiscal year ending September 30, 1996, any amend-
7 ment thereto, any conference report thereon, or any
8 amendment reported in disagreement from a con-
9 ference thereon.

10 (2) A bill or joint resolution that includes provi-
11 sions making further continuing appropriations for
12 the fiscal year 1996, any amendment thereto, any
13 conference report thereon, or any amendment re-
14 ported in disagreement from a conference thereon.

15 (3) A bill or joint resolution that includes provi-
16 sions increasing or waiving (for a temporary period
17 or otherwise) the public debt limit under section
18 3101(b) of title 31, United States Code, any amend-
19 ment thereto, any conference report thereon, or any
20 amendment reported in disagreement from a con-
21 ference thereon.

22 (4) A bill to provide for a balanced budget by
23 2002, any amendment thereto, any conference report
24 thereon, or any amendment reported in disagree-
25 ment from a conference thereon.
