RESOLUTION

Providing for consideration of the joint resolution (H.J. Res. 165) making further continuing appropriations for the fiscal year 1996, and for other purposes, and waiving a requirement of clause 4(b) of rule XI with respect to consideration of certain resolutions reported from the Committee on Rules.

- 1 *Resolved*, That upon the adoption of this resolution
- 2 it shall be in order to consider in the House the joint reso-
- 3 lution (H.J. Res. 165) making further continuing appro-

1 appropriations for the fiscal year 1996, and for other purposes.
2 The joint resolution shall be debatable for one hour equal-
3 ly divided and controlled by the chairman and ranking mi-
4 nority member of the Committee on Appropriations. The
5 previous question shall be considered as ordered on the
6 joint resolution to final passage without intervening mo-
7 tion except one motion to recommit. The motion to recom-
8 mit may include instructions only if offered by the minor-
9 ity leader or his designee.

10 SEC. 2. The requirement of clause 4(b) of rule XI
11 for a two-thirds vote to consider a report from the Com-
12 mittee on Rules on the same day it is presented to the
13 House is waived with respect to any resolution reported
14 from that committee before April 1, 1996, and providing
15 for consideration or disposition of any of the following
16 measures:

17 (1) A bill making general appropriations for the
18 fiscal year ending September 30, 1996, any amend-
19 ment thereto, any conference report thereon, or any
20 amendment reported in disagreement from a con-
21 ference thereon.

22 (2) A bill or joint resolution that includes provi-
23 sions making further continuing appropriations for
24 the fiscal year 1996, any amendment thereto, any

1 conference report thereon, or any amendment re-
2 ported in disagreement from a conference thereon.

3 (3) A bill or joint resolution that includes provi-
4 sions increasing or waiving (for a temporary period
5 or otherwise) the public debt limit under section
6 3101(b) of title 31, United States Code, any amend-
7 ment thereto, any conference report thereon, or any
8 amendment reported in disagreement from a con-
9 ference thereon.
