Mr. DREIER, from the Committee on Rules, reported the following resolution which was referred to the House Calendar and ordered to be printed

---

## RESOLUTION

Providing for the consideration of the bill (H.R. 5) to curb the practice of imposing unfunded Federal mandates on States and local governments, to ensure that the Federal Government pays the costs incurred by those governments in complying with certain requirements under Federal statutes and regulations, and to provide information on the cost of Federal mandates on the private sector, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of  
3 rule XXIII, declare the House resolved into the Committee  
4 of the Whole House on the state of the Union for consider-  
5 ation of the bill (H.R. 5) to curb the practice of imposing  
6 unfunded Federal mandates on States and local govern-  
7 ments, to ensure that the Federal Government pays the  
8 costs incurred by those governments in complying with  
9 certain requirements under Federal statutes and regula-  
10 tions, and to provide information on the cost of Federal  
11 mandates on the private sector, and for other purposes.  
12 The first reading of the bill shall be dispensed with. Gen-  
13 eral debate shall be confined to the bill and shall not ex-  
14 ceed two hours, with one hour equally divided and con-  
15 trolled by the chairman and ranking minority member of  
16 the Committee on Government Reform and Oversight and  
17 one hour equally divided and controlled by the chairman  
18 and ranking minority member of the Committee on Rules.  
19 After general debate the bill shall be considered for  
20 amendment under the five-minute rule. In lieu of the  
21 amendments recommended by the Committee on Govern-  
22 ment Reform and Oversight and the Committee on Rules,  
23 it shall be in order to consider as an original bill for the  
24 purpose of amendment under the five-minute rule the  
25 amendment in the nature of a substitute printed in the

1 report of the Committee on Rules accompanying this reso-  
2 lution. That amendment in the nature of a substitute shall  
3 be considered by title rather than by section. Each of the  
4 first four sections and each title shall be considered as  
5 read. During consideration of the bill for amendment, the  
6 Chairman of the Committee of the Whole may accord pri-  
7 ority in recognition on the basis of whether the Member  
8 offering an amendment has caused it to be printed in the  
9 portion of the Congressional Record designated for that  
10 purpose in clause 6 of rule XXIII. Amendments so printed  
11 shall be considered as read. At the conclusion of consider-  
12 ation of the bill for amendment the Committee shall rise  
13 and report the bill to the House with such amendments  
14 as may have been adopted. Any Member may demand a  
15 separate vote in the House on any amendment adopted  
16 in the Committee of the Whole to the bill or to the amend-  
17 ment in the nature of a substitute made in order as origi-  
18 nal text. The previous question shall be considered as or-  
19 dered on the bill and amendments thereto to final passage  
20 without intervening motion except one motion to recommit  
21 with or without instructions.
