Mrs. JOHNSON of Connecticut (for herself and Mr. McDERMOTT) submitted the following resolution; which was referred to the Committee on House Oversight

## RESOLUTION

Providing amounts for the expenses of the Committee on Standards of Official Conduct in the One Hundred Fourth Congress.

1       *Resolved,*

2       **SECTION 1. AMOUNTS FOR COMMITTEE EXPENSES.**

3       For the expenses of the Committee on Standards of  
4       Official Conduct (hereinafter in this resolution referred to  
5       as the “Committee”), including—

6               (1) the expenses of all staff salaries; and

7               (2) the expenses of consultant services under  
8       section 202(i) of the Legislative Reorganization Act  
9       of 1946 (2 U.S.C. 72a(i));

1 there shall be paid, out of the applicable accounts of the  
2 House of Representatives for committee salaries and ex-  
3 penses, not more than \$2,090,150 for the One Hundred  
4 Fourth Congress.

5 **SEC. 2. SESSION LIMITATIONS.**

6 Of the amount specified in section 1—

7 (1) not more than \$1,063,650 shall be available  
8 for expenses incurred during the period beginning at  
9 noon on January 3, 1995, and ending immediately  
10 before noon on January 3, 1996; and

11 (2) not more than \$1,026,500 shall be available  
12 for expenses incurred during the period beginning at  
13 noon on January 3, 1996, and ending immediately  
14 before noon on January 3, 1997.

15 **SEC. 3. CONSULTANT SERVICES.**

16 Of the amount specified—

17 (1) in paragraph (1) of section 2, not more  
18 than \$50,000 may be used for consultant services  
19 referred to in section 1; and

20 (2) in paragraph (2) of section 2, not more  
21 than \$50,000 may be used for consultant services  
22 referred to in section 1.

23 **SEC. 4. VOUCHERS.**

24 Payments under this resolution shall be made on  
25 vouchers authorized by the Committee, signed by the

1 Chairman of the Committee, and approved in the manner  
2 directed by the Committee on House Oversight.

3 **SEC. 5. REGULATIONS.**

4       Amounts made available under this resolution shall  
5 be expended in accordance with regulations prescribed by  
6 the Committee on House Oversight.
