Mr. QUILLEN, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

## RESOLUTION

Providing for consideration of the bill (H.R. 831) to amend the Internal Revenue Code of 1986 to permanently extend the deduction for the health insurance costs of self-employed individuals, to repeal the provision permitting nonrecognition of gain on sales and exchanges effectuating policies of the Federal Communications Commission, and for other purposes.

1       *Resolved*, That at any time after the adoption of this  
2 resolution the Speaker may, pursuant to clause 1(b) of

1 rule XXIII, declare the House resolved into the Committee  
2 of the Whole House on the state of the Union for consider-  
3 ation of the bill (H.R. 831) to amend the Internal Revenue  
4 Code of 1986 to permanently extend the deduction for  
5 health insurance costs of self-employed individuals, to re-  
6 peal the provision permitting nonrecognition of gain on  
7 sales and exchanges effectuating policies of the Federal  
8 Communications Commission, and for other purposes. The  
9 first reading of the bill shall be dispensed with. All points  
10 of order against consideration of the bill are waived. Gen-  
11 eral debate shall be confined to the bill and the amend-  
12 ment made in order by this resolution and shall not exceed  
13 one hour equally divided and controlled by the chairman  
14 and ranking minority member of the Committee on Ways  
15 and Means. After general debate the bill shall be consid-  
16 ered for amendment under the five-minute rule. The  
17 amendment recommended by the Committee on Ways and  
18 means now printed in the bill shall be considered as adopt-  
19 ed in the House and in the Committee of the Whole. The  
20 bill, as amended, shall be considered as read. No further  
21 amendment shall be in order except the amendment in the  
22 nature of a substitute printed in the report of the Commit-  
23 tee on Rules accompanying this resolution, which may be  
24 offered only by Representative Gibbons of Florida or his  
25 designee, shall be considered as read, shall be debatable

1 for one hour equally divided and controlled by the pro-  
2 ponent and an opponent, and shall not be subject to  
3 amendment. All points of order against that amendment  
4 are waived. At the conclusion of consideration of the bill  
5 for amendment the Committee shall rise and report the  
6 bill to the House with such further amendment as may  
7 have been adopted. The previous question shall be consid-  
8 ered as ordered on the bill and any amendment thereto  
9 to final passage without intervening motion except one  
10 motion to recommit with or without instructions.
