Mr. SANDERS submitted the following concurrent resolution; which was referred to the Committee on the Budget

CONCURRENT RESOLUTION

Revising the congressional budget for the United States Government for fiscal year 1998 with respect to the appropriate budgetary levels for Social Security and national defense for fiscal years 1999 through 2002 in order to maintain the level of administrative expenses for Social Security by taking into account anticipated inflation.

3 **SECTION 1. PURPOSE.**

4 It is the purpose of this concurrent resolution to re-
5 vise the concurrent resolution on the budget for fiscal year
6 1998 to increase the budget authority available for admin-

1 istrative expenses for social security in order to reflect due
2 consideration of the impact of anticipated inflation on the
3 administrative expenses of such program.

4 **SEC. 2. INCREASE IN APPROPRIATE BUDGETARY LEVELS**
5 **FOR SOCIAL SECURITY FOR FISCAL YEARS**
6 **1999 THROUGH 2002.**

7 Pursuant to section 304 of the Congressional Budget
8 Act of 1974, House Concurrent Resolution 84 (105th
9 Congress, as agreed to on June 5, 1997) is amended as
10 follows:

11 (1) INCREASE IN NEW BUDGET AUTHORITY
12 AND BUDGET OUTLAYS FOR SOCIAL SECURITY
13 (MAJOR FUNCTIONAL CATEGORY 650).—In section
14 103(14), increase the dollar amounts for new budget
15 authority and budget outlays otherwise provided as
16 follows:

17 (A) For fiscal year 1999, increase the
18 amount of new budget authority by
19 \$486,000,000 and increase budget outlays by
20 \$335,000,000.

21 (B) For fiscal year 2000, increase the
22 amount of new budget authority by
23 \$634,000,000 and increase budget outlays by
24 \$544,000,000.

1 (C) For fiscal year 2001, increase the
2 amount of new budget authority by
3 \$790,000,000 and increase budget outlays by
4 \$752,000,000.

5 (D) For fiscal year 2002, increase the
6 amount of new budget authority by
7 \$954,000,000 and increase budget outlays by
8 \$921,000,000.

9 (2) OFFSETTING DECREASE IN NEW BUDGET
10 AUTHORITY AND BUDGET OUTLAYS FOR NATIONAL
11 DEFENSE (MAJOR FUNCTIONAL CATEGORY 050).—In
12 section 103(1), decrease the dollar amounts for new
13 budget authority and budget outlays otherwise pro-
14 vided as follows:

15 (A) For fiscal year 1999, decrease the
16 amount of new budget authority by
17 \$486,000,000 and decrease budget outlays by
18 \$335,000,000.

19 (B) For fiscal year 2000, decrease the
20 amount of new budget authority by
21 \$634,000,000 and decrease budget outlays by
22 \$544,000,000.

23 (C) For fiscal year 2001, decrease the
24 amount of new budget authority by

1 \$790,000,000 and decrease budget outlays by
2 \$752,000,000.

3 (D) For fiscal year 2002, decrease the
4 amount of new budget authority by
5 \$954,000,000 and decrease budget outlays by
6 \$921,000,000.
