CONCURRENT RESOLUTION

Authorizing the use of the Capitol grounds for the sixteenth annual National Peace Officers' Memorial Service.

1 *Resolved by the House of Representatives (the Senate*
2 *concurring),*

3 **SECTION 1. USE OF CAPITOL GROUNDS FOR NATIONAL**
4 **PEACE OFFICERS' MEMORIAL SERVICE.**

5 The National Fraternal Order of Police and its auxil-
6 iary shall be permitted to sponsor a public event, the six-

1 tenth annual National Peace Officers' Memorial Service,
2 on the Capitol grounds on May 15, 1997, or on such other
3 date as the Speaker of the House of Representatives and
4 the President pro tempore of the Senate may jointly des-
5 ignate, in order to honor the more than 117 law enforce-
6 ment officers who died in the line of duty during 1996.

7 **SEC. 2. TERMS AND CONDITIONS.**

8 (a) **IN GENERAL.**—The event authorized to be con-
9 ducted on the Capitol grounds under section 1 shall be
10 free of admission charge to the public and arranged not
11 to interfere with the needs of Congress, under conditions
12 to be prescribed by the Architect of the Capitol and the
13 Capitol Police Board.

14 (b) **EXPENSES AND LIABILITIES.**—The National
15 Fraternal Order of Police and its auxiliary shall assume
16 full responsibility for all expenses and liabilities incident
17 to all activities associated with the event.

18 **SEC. 3. EVENT PREPARATIONS.**

19 (a) **STRUCTURES AND EQUIPMENT.**—Subject to the
20 approval of the Architect of the Capitol, the National Fra-
21 ternal Order of Police and its auxiliary are authorized to
22 erect upon the Capitol grounds such stage, sound amplifi-
23 cation devices, and other related structures and equip-
24 ment, as may be required for the event authorized to be
25 conducted on the Capitol grounds under section 1.

1 (b) ADDITIONAL ARRANGEMENTS.—The Architect of
2 the Capitol and the Capitol Police Board are authorized
3 to make any such additional arrangements as may be re-
4 quired to carry out the event.
