10 **SECTION 1. DISAPPROVAL OF DETERMINATION OF PRESI-**
11 **DENT REGARDING MEXICO.**

12 *Pursuant to subsection (d) of section 490 of the For-*
13 *ign Assistance Act of 1961 (22 U.S.C. 2291j), Congress dis-*
14 *approves the determination of the President with respect to*
15 *Mexico for fiscal year 1997 that is contained in the certifi-*
16 *cation (transmittal no. 97-18) submitted to Congress by the*
17 *President under subsection (b) of that section on February*
18 *28, 1997.*

19 **SEC. 2. WAIVER OF REQUIREMENT TO WITHHOLD ASSIST-**
20 **ANCE FOR MEXICO.**

21 *(a) WAIVER.—Notwithstanding subsections (e) and (f)*
22 *of section 490 of the Foreign Assistance Act of 1961, the*
23 *requirement to withhold United States assistance and to*
24 *vote against multilateral development bank assistance con-*
25 *tained in such subsection (e) shall not apply with respect*

1 *to Mexico until March 1, 1998, if at any time after the*
2 *date of the enactment of this joint resolution, the President*
3 *submits to Congress a determination and certification de-*
4 *scribed in subsection (b) of this section.*

5 **(b) DETERMINATION AND CERTIFICATION.**—*A deter-*
6 *mination and certification described in this subsection is*
7 *a determination and certification consistent with section*
8 *490(b)(1)(B) of the Foreign Assistance Act of 1961 that the*
9 *vital national interests of the United States require that*
10 *the assistance withheld pursuant to section 490(e)(1) of such*
11 *Act be provided for Mexico and that the United States not*
12 *vote against multilateral development bank assistance for*
13 *Mexico pursuant to section 490(e)(2) of such Act.*

14 **SEC. 3. RULE OF CONSTRUCTION.**

15 *For purposes of section 490(d) of the Foreign Assist-*
16 *ance Act of 1961, this joint resolution shall be deemed to*
17 *have been enacted within 30 calendar days after February*
18 *28, 1997.*

19 **SEC. 4. CONSULTATIONS WITH THE CONGRESS.**

20 **(a) CONSULTATIONS.**—*The President shall consult*
21 *with the Congress on the status of counter-narcotics co-*
22 *operation between the United States and each major illicit*
23 *drug producing country or major drug-transit country.*

24 **(b) PURPOSE.**—

1 (1) *IN GENERAL.*—*The purpose of the consulta-*
2 *tions under subsection (a) shall be to facilitate im-*
3 *proved discussion and understanding between the*
4 *Congress and the President on United States counter-*
5 *narcotics goals and objectives with regard to the coun-*
6 *tries described in subsection (a), including the strat-*
7 *egy for achieving such goals and objectives.*

8 (2) *REGULAR AND SPECIAL CONSULTATIONS.*—*In*
9 *order to carry out paragraph (1), the President (or*
10 *senior officials designated by the President who are*
11 *responsible for international narcotics programs and*
12 *policies) shall meet with Members of Congress—*

13 (A) *on a quarterly basis for discussions and*
14 *consultations; and*

15 (B) *whenever time-sensitive issues arise.*
