1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE; TABLE OF CONTENTS.**

4 (a) *SHORT TITLE.*—*This Act may be cited as the*  
 5 *“Ricky Ray Hemophilia Relief Fund Act of 1998”.*

6 (b) *TABLE OF CONTENTS.*—*The table of contents of this*  
 7 *Act is as follows:*

*Sec. 1. Short title; table of contents.*

### TITLE I—HEMOPHILIA RELIEF FUND

*Sec. 101. Ricky Ray Hemophilia Relief Fund.*

*Sec. 102. Compassionate payment relating to individuals with blood-clotting disorders and HIV.*

*Sec. 103. Determination and payment.*



1 *uidated, the receipts of such liquidation shall be deposited*

5 *(e) AUTHORIZATION OF APPROPRIATIONS.—There is*  
6 *authorized to be appropriated to the Fund to carry out this*  
7 *title \$750,000,000.*

8 **SEC. 102. COMPASSIONATE PAYMENT RELATING TO INDI-**  
9 **VIDUALS WITH BLOOD-CLOTTING DISORDERS**  
10 **AND HIV.**

11 *(a) IN GENERAL.—If the conditions described in sub-*  
12 *section (b) are met and if there are sufficient amounts in*  
13 *the Fund to make each payment, the Secretary shall make*  
14 *a single payment of \$100,000 from the Fund to any indi-*  
15 *vidual who has an HIV infection and who is described in*  
16 *one of the following paragraphs:*

17 *(1) The individual has any form of blood-clotting*  
18 *disorder, such as hemophilia, and was treated with*  
19 *antihemophilic factor at any time during the period*  
20 *beginning on July 1, 1982, and ending on December*  
21 *31, 1987.*

22 *(2) The individual —*

23 *(A) is the lawful spouse of an individual de-*  
24 *scribed in paragraph (1); or*

1           (B) is the former lawful spouse of an indi-  
2           vidual described in paragraph (1) and was the  
3           lawful spouse of the individual at any time after  
4           a date, within the period described in such sub-  
5           paragraph, on which the individual was treated  
6           as described in such paragraph and through  
7           medical documentation can assert reasonable cer-  
8           tainty of transmission of HIV from individual  
9           described in paragraph (1).

10           (3) The individual acquired the HIV infection  
11           through perinatal transmission from a parent who is  
12           an individual described in paragraph (1) or (2).

13           (b) CONDITIONS.—The conditions described in this  
14           subsection are, with respect to an individual, as follows:

15           (1) SUBMISSION OF MEDICAL DOCUMENTATION  
16           OF HIV INFECTION.—The individual submits to the  
17           Secretary written medical documentation that the in-  
18           dividual has an HIV infection.

19           (2) PETITION.—A petition for the payment is  
20           filed with the Secretary by or on behalf of the individ-  
21           ual.

22           (3) DETERMINATION.—The Secretary determines,  
23           in accordance with section 103(b), that the petition  
24           meets the requirements of this title.

1 **SEC. 103. DETERMINATION AND PAYMENT.**

2       (a) *ESTABLISHMENT OF FILING PROCEDURES.*—The  
3 Secretary of Health and Human Services shall establish  
4 procedures under which individuals may submit petitions  
5 for payment under this title. The procedures shall include  
6 a requirement that each petition filed under this Act in-  
7 clude written medical documentation that the relevant indi-  
8 vidual described in section 102(a)(1) has (or had) a blood-  
9 clotting disorder, such as hemophilia, and was treated as  
10 described in such section.

11       (b) *DETERMINATION.*—For each petition filed under  
12 this title, the Secretary shall determine whether the petition  
13 meets the requirements of this title.

14       (c) *PAYMENT.*—

15           (1) *IN GENERAL.*—To the extent there are suffi-  
16 cient amounts in the Fund to cover each payment, the  
17 Secretary shall pay, from the Fund, each petition  
18 that the Secretary determines meets the requirements  
19 of this title in the order received.

20           (2) *PAYMENTS IN CASE OF DECEASED INDIVID-*  
21 *UALS.*—

22           (A) *IN GENERAL.*—In the case of an indi-  
23 vidual referred to in section 102(a) who is de-  
24 ceased at the time that payment is made under  
25 this section on a petition filed by or on behalf of

1           *the individual, the payment shall be made as fol-*  
2           *lows:*

3                     *(i) If the individual is survived by a*  
4                     *spouse who is living at the time of payment,*  
5                     *the payment shall be made to such surviv-*  
6                     *ing spouse.*

7                     *(ii) If the individual is not survived by*  
8                     *a spouse described in clause (i), the pay-*  
9                     *ment shall be made in equal shares to all*  
10                    *children of the individual who are living at*  
11                    *the time of the payment.*

12                    *(iii) If the individual is not survived*  
13                    *by a person described in clause (i) or (ii),*  
14                    *the payment shall be made in equal shares*  
15                    *to the parents of the individual who are liv-*  
16                    *ing at the time of payment.*

17                    *(iv) If the individual is not survived*  
18                    *by a person described in clause (i), (ii), or*  
19                    *(iii), the payment shall revert back to the*  
20                    *Fund.*

21                    *(B) FILING OF PETITION BY SURVIVOR.—If*  
22                    *an individual eligible for payment under section*  
23                    *102(a) dies before filing a petition under this*  
24                    *title, a survivor of the individual may file a pe-*  
25                    *tition for payment under this title on behalf of*

1           *the individual if the survivor may receive pay-*  
2           *ment under subparagraph (A).*

3           (C) *DEFINITIONS.—For purposes of this*  
4           *paragraph:*

5                   (i) *The term “spouse” means an indi-*  
6                   *vidual who was lawfully married to the rel-*  
7                   *evant individual at the time of death.*

8                   (ii) *The term “child” includes a recog-*  
9                   *nized natural child, a stepchild who lived*  
10                  *with the relevant individual in a regular*  
11                  *parent-child relationship, and an adopted*  
12                  *child.*

13                  (iii) *The term “parent” includes fa-*  
14                  *thers and mothers through adoption.*

15           (3) *TIMING OF PAYMENT.—The Secretary may*  
16           *not make a payment on a petition under this title be-*  
17           *fore the expiration of the 120-day period beginning on*  
18           *the date of the enactment of this Act or after the expi-*  
19           *ration of the 5-year period beginning on the date of*  
20           *the enactment of this Act.*

21           (d) *ACTION ON PETITIONS.—The Secretary shall com-*  
22           *plete the determination required by subsection (b) regarding*  
23           *a petition not later than 120 days after the date the petition*  
24           *is filed under this title.*

1           (e) *HUMANITARIAN NATURE OF PAYMENT.*—*This Act*  
2 *does not create or admit any claim of or on behalf of the*  
3 *individual against the United States or against any officer,*  
4 *employee, or agent thereof acting within the scope of em-*  
5 *ployment or agency that relate to an HIV infection arising*  
6 *from treatment with antihemophilic factor, at any time*  
7 *during the period beginning on July 1, 1982, and ending*  
8 *on December 31, 1987. A payment under this Act shall,*  
9 *however, when accepted by or on behalf of the individual,*  
10 *be in full satisfaction of all such claims by or on behalf*  
11 *of that individual.*

12           (f) *ADMINISTRATIVE COSTS NOT PAID FROM FUND.*—  
13 *No costs incurred by the Secretary in carrying out this title*  
14 *may be paid from the Fund or set off against, or otherwise*  
15 *deducted from, any payment made under subsection (c)(1).*

16           (g) *TERMINATION OF DUTIES OF SECRETARY.*—*The*  
17 *duties of the Secretary under this section shall cease when*  
18 *the Fund terminates.*

19           (h) *TREATMENT OF PAYMENTS UNDER OTHER*  
20 *LAWS.*—*A payment under subsection (c)(1) to an individ-*  
21 *ual—*

22                   (1) *shall be treated for purposes of the internal*  
23 *revenue laws of the United States as damages received*  
24 *on account of personal injuries or sickness;*

1           **(1) shall be treated for purposes of**  
2           **the Internal Revenue Code of 1986 as**  
3           **damages described in section 104(a)(2) of**  
4           **such Code;**

5           *(2) shall not be included as income or resources*  
6           *for purposes of determining the eligibility of the indi-*  
7           *vidual to receive benefits described in section*  
8           *3803(c)(2)(C) of title 31, United States Code, or the*  
9           *amount of such benefits, and such benefits shall not*  
10          *be secondary to, conditioned upon reimbursement*  
11          *from, or subject to any reduction because of receipt*  
12          *of, any such payment; and*

13          *(3) shall not be treated as a third party payment*  
14          *or payment in relation to a legal liability with re-*  
15          *spect to such benefits and shall not be subject (whether*  
16          *by subrogation or otherwise) to recovery, recoupment,*  
17          *reimbursement, or collection with respect to such ben-*  
18          *efits (including the Federal or State governments or*  
19          *any entity that provides such benefits under a con-*  
20          *tract).*

21          *(i) REGULATORY AUTHORITY.—The Secretary may*  
22          *issue regulations necessary to carry out this title.*

23          *(j) TIME OF ISSUANCE OF PROCEDURES.—The Sec-*  
24          *retary shall, through the promulgation of appropriate regu-*  
25          *lations, guidelines, or otherwise, first establish the proce-*

1 *dures to carry out this title not later than 120 days after*  
2 *the date of the enactment of this Act.*

3 **SEC. 104. LIMITATION ON TRANSFER OF RIGHTS AND NUM-**  
4 **BER OF PETITIONS.**

5 *(a) RIGHTS NOT ASSIGNABLE OR TRANSFERABLE.—*  
6 *Any right under this title shall not be assignable or trans-*  
7 *ferable.*

8 *(b) 1 PETITION WITH RESPECT TO EACH VICTIM.—*  
9 *With respect to each individual described in paragraph (1),*  
10 *(2), or (3) of section 102(a), the Secretary may not make*  
11 *payment with respect to more than 1 petition filed in re-*  
12 *spect to an individual.*

13 **SEC. 105. TIME LIMITATION.**

14 *The Secretary may not make any payment with re-*  
15 *spect to any petition filed under this title unless the petition*  
16 *is filed within 3 years after the date of the enactment of*  
17 *this Act.*

18 **SEC. 106. CERTAIN CLAIMS NOT AFFECTED BY PAYMENT.**

19 *A payment made under section 103(c)(1) shall not be*  
20 *considered as any form of compensation, or reimbursement*  
21 *for a loss, for purposes of imposing liability on the individ-*  
22 *ual receiving the payment, on the basis of such receipt, to*  
23 *repay any insurance carrier for insurance payments or to*  
24 *repay any person on account of worker's compensation pay-*  
25 *ments. A payment under this title shall not affect any claim*

1 *against an insurance carrier with respect to insurance or*  
2 *against any person with respect to worker's compensation.*

3 **SEC. 107. LIMITATION ON AGENT AND ATTORNEY FEES.**

4 *Notwithstanding any contract, the representative of an*  
5 *individual may not receive, for services rendered in connec-*  
6 *tion with the petition of an individual under this title, more*  
7 *than 2 percent of a payment made under this title on the*  
8 *petition. Any such representative who violates this section*  
9 *shall be fined not more than \$50,000.*

10 **SEC. 108. DEFINITIONS.**

11 *For purposes of this title:*

12 *(1) The term "AIDS" means acquired immune*  
13 *deficiency syndrome.*

14 *(2) The term "Fund" means the Ricky Ray He-*  
15 *mophilia Relief Fund.*

16 *(3) The term "HIV" means human immuno-*  
17 *deficiency virus.*

18 *(4) Unless otherwise provided, the term "Sec-*  
19 *retary" means Secretary of Health and Human*
