1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. REDESIGNATION.**

2 The Federal building located at 100 Franklin Street
3 in Dublin, Georgia, and known as the Dublin Federal
4 Courthouse, shall be known and designated as the “J. Roy
5 Rowland Federal Courthouse”.

6 **SEC. 2. REFERENCES.**

7 Any reference in a law, map, regulation, document,
8 paper, or other record of the United States to the Federal
9 building referred to in section 1 shall be deemed to be
10 a reference to the “J. Roy Rowland Federal Courthouse”.

11 **SECTION 1. REDESIGNATION.**

12 *The United States courthouse located at 100 Franklin*
13 *Street in Dublin, Georgia, and known as the Dublin Fed-*
14 *eral Courthouse, shall be known and designated as the “J.*
15 *Roy Rowland United States Courthouse”.*

16 **SEC. 2. REFERENCES.**

17 *Any reference in a law, map, regulation, document,*
18 *paper, or other record of the United States to the United*
19 *States courthouse referred to in section 1 shall be deemed*
20 *to be a reference to the “J. Roy Rowland United States*
21 *Courthouse”.*

Amend the title so as to read: “A bill to redesignate the United States courthouse located at 100 Franklin Street in Dublin, Georgia, as the ‘J. Roy Rowland United States Courthouse’.”.
