AN ACT

Making appropriations for Agriculture, Rural Development, Food and Drug Administration, and Related Agencies programs for the fiscal year ending September 30, 1998, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*
3 **(1)** That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for Ag-
5 riculture, Rural Development, Food and Drug Administra-
6 tion, and Related Agencies programs for the fiscal year
7 ending September 30, 1998, and for other purposes,
8 namely:

1 TITLE I
2 AGRICULTURAL PROGRAMS
3 PRODUCTION, PROCESSING, AND MARKETING
4 OFFICE OF THE SECRETARY
5 (INCLUDING TRANSFERS OF FUNDS)

6 For necessary expenses of the Office of the Secretary
7 of Agriculture, and not to exceed \$75,000 for employment
8 under 5 U.S.C. 3109, \$2,836,000: *Provided*, That not to
9 exceed \$11,000 of this amount, along with any unobli-
10 gated balances of representation funds in the Foreign Ag-
11 ricultural Service, shall be available for official reception
12 and representation expenses, not otherwise provided for,
13 as determined by the Secretary.

14 EXECUTIVE OPERATIONS
15 CHIEF ECONOMIST

16 For necessary expenses of the Chief Economist, in-
17 cluding economic analysis, risk assessment, cost-benefit
18 analysis, and the functions of the World Agricultural Out-
19 look Board, as authorized by the Agricultural Marketing
20 Act of 1946 (7 U.S.C. 1622g), and including employment
21 pursuant to the second sentence of section 706(a) of the
22 Organic Act of 1944 (7 U.S.C. 2225), of which not to
23 exceed \$5,000 is for employment under 5 U.S.C. 3109,
24 \$4,844,000.

1 NATIONAL APPEALS DIVISION

2 For necessary expenses of the National Appeals Divi-
3 sion, including employment pursuant to the second sen-
4 tence of section 706(a) of the Organic Act of 1944 (7
5 U.S.C. 2225), of which not to exceed \$25,000 is for em-
6 ployment under 5 U.S.C. 3109, \$11,718,000.

7 OFFICE OF BUDGET AND PROGRAM ANALYSIS

8 For necessary expenses of the Office of Budget and
9 Program Analysis, including employment pursuant to the
10 second sentence of section 706(a) of the Organic Act of
11 1944 (7 U.S.C. 2225), of which not to exceed \$5,000 is
12 for employment under 5 U.S.C. 3109, \$5,986,000.

13 OFFICE OF THE CHIEF INFORMATION OFFICER

14 For necessary expenses of the Office of the Chief In-
15 formation Officer, including employment pursuant to the
16 second sentence of section 706(a) of the Organic Act of
17 1944 (7 U.S.C. 2225), of which not to exceed \$10,000
18 is for employment under 5 U.S.C. 3109, \$4,773,000.

19 OFFICE OF THE CHIEF FINANCIAL OFFICER

20 For necessary expenses of the Office of the Chief Fi-
21 nancial Officer, including employment pursuant to the sec-
22 ond sentence of section 706(a) of the Organic Act of 1944
23 (7 U.S.C. 2225), of which not to exceed \$10,000 is for
24 employment under 5 U.S.C. 3109, \$4,283,000. *Provided,*
25 That the Chief Financial Officer shall actively market
26 cross-servicing activities of the National Finance Center.

1 equipment or facilities as necessary to carry out the pro-
2 grams of the Department, where not otherwise provided,
3 \$15,000,000, to remain available until expended; and in
4 addition, for necessary relocation expenses of the Depart-
5 ment's agencies, \$2,700,000, to remain available until ex-
6 pended; making a total appropriation of \$141,085,000.

7 HAZARDOUS WASTE MANAGEMENT

8 (INCLUDING TRANSFERS OF FUNDS)

9 For necessary expenses of the Department of Agri-
10 culture, to comply with the requirement of section 107(g)
11 of the Comprehensive Environmental Response, Com-
12 pensation, and Liability Act, as amended, 42 U.S.C.
13 9607(g), and section 6001 of the Resource Conservation
14 and Recovery Act, as amended, 42 U.S.C. 6961,
15 \$20,000,000, to remain available until expended: *Pro-*
16 *vided*, That appropriations and funds available herein to
17 the Department for Hazardous Waste Management may
18 be transferred to any agency of the Department for its
19 use in meeting all requirements pursuant to the above
20 Acts on Federal and non-Federal lands.

21 DEPARTMENTAL ADMINISTRATION

22 (INCLUDING TRANSFERS OF FUNDS)

23 For Departmental Administration, \$25,731,000, to
24 provide for necessary expenses for management support
25 services to offices of the Department and for general ad-

1 ministration and disaster management of the Department,
2 repairs and alterations, and other miscellaneous supplies
3 and expenses not otherwise provided for and necessary for
4 the practical and efficient work of the Department, includ-
5 ing employment pursuant to the second sentence of section
6 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), of
7 which not to exceed \$10,000 is for employment under 5
8 U.S.C. 3109: *Provided*, That this appropriation shall be
9 reimbursed from applicable appropriations in this Act for
10 travel expenses incident to the holding of hearings as re-
11 quired by 5 U.S.C. 551–558.

12 OFFICE OF THE ASSISTANT SECRETARY FOR
13 CONGRESSIONAL RELATIONS
14 (INCLUDING TRANSFERS OF FUNDS)

15 For necessary salaries and expenses of the Office of
16 the Assistant Secretary for Congressional Relations to
17 carry out the programs funded in this Act, including pro-
18 grams involving intergovernmental affairs and liaison
19 within the executive branch, \$3,668,000: *Provided*, That
20 no other funds appropriated to the Department in this Act
21 shall be available to the Department for support of activi-
22 ties of congressional relations: *Provided further*, That not
23 less than \$2,241,000 shall be transferred to agencies fund-
24 ed in this Act to maintain personnel at the agency level.

1 the direction of the Inspector General pursuant to Public
2 Law 95-452 and section 1337 of Public Law 97-98: *Pro-*
3 *vided*, That funds transferred to the Office of the Inspee-
4 tor General through forfeiture proceedings or from the De-
5 partment of Justice Assets Forfeiture Fund or the De-
6 partment of the Treasury Forfeiture Fund, as a partici-
7 pating agency, as an equitable share from the forfeiture
8 of property in investigations in which the Office of the In-
9 spector General participates, or through the granting of
10 a Petition for Remission or Mitigation, shall be deposited
11 to the credit of this account for law enforcement activities
12 authorized under the Inspector General Act of 1978, as
13 amended, to remain available until expended.

15 For necessary expenses of the Office of the General
16 Counsel, \$27,949,000.

17 OFFICE OF THE UNDER SECRETARY FOR RESEARCH,
18 EDUCATION AND ECONOMICS

19 For necessary salaries and expenses of the Office of
20 the Under Secretary for Research, Education and Eco-
21 nomics to administer the laws enacted by the Congress
22 for the Economic Research Service, the National Agricult-
23 tural Statistics Service, the Agricultural Research Service,
24 and the Cooperative State Research, Education, and Ex-
25 tension Service, \$540,000.

1 ECONOMIC RESEARCH SERVICE

2 For necessary expenses of the Economic Research
3 Service in conducting economic research and analysis, as
4 authorized by the Agricultural Marketing Act of 1946 (7
5 U.S.C. 1621–1627) and other laws, \$71,604,000: *Pro-*
6 *vided*, That this appropriation shall be available for em-
7 ployment pursuant to the second sentence of section
8 706(a) of the Organic Act of 1944 (7 U.S.C. 2225).

9 NATIONAL AGRICULTURAL STATISTICS SERVICE

10 For necessary expenses of the National Agricultural
11 Statistics Service in conducting statistical reporting and
12 service work, including crop and livestock estimates, sta-
13 tistical coordination and improvements, marketing sur-
14 veys, and the Census of Agriculture notwithstanding 13
15 U.S.C. 142(a) and (b), as authorized by the Agricultural
16 Marketing Act of 1946 (7 U.S.C. 1621–1627) and other
17 laws, \$118,361,000, of which up to \$36,140,000 shall be
18 available until expended for the Census of Agriculture:
19 *Provided*, That this appropriation shall be available for
20 employment pursuant to the second sentence of section
21 706(a) of the Organic Act of 1944 (7 U.S.C. 2225), and
22 not to exceed \$40,000 shall be available for employment
23 under 5 U.S.C. 3109.

1 AGRICULTURAL RESEARCH SERVICE

2 For necessary expenses to enable the Agricultural Re-
3 search Service to perform agricultural research and dem-
4 onstration relating to production, utilization, marketing,
5 and distribution (not otherwise provided for); home eco-
6 nomics or nutrition and consumer use including the acqui-
7 sition, preservation, and dissemination of agricultural in-
8 formation; and for acquisition of lands by donation, ex-
9 change, or purchase at a nominal cost not to exceed \$100,
10 \$725,059,000: *Provided*, That appropriations hereunder
11 shall be available for temporary employment pursuant to
12 the second sentence of section 706(a) of the Organic Act
13 of 1944 (7 U.S.C. 2225), and not to exceed \$115,000 shall
14 be available for employment under 5 U.S.C. 3109: *Pro-*
15 *vided further*, That appropriations hereunder shall be
16 available for the operation and maintenance of aircraft
17 and the purchase of not to exceed one for replacement
18 only: *Provided further*, That appropriations hereunder
19 shall be available pursuant to 7 U.S.C. 2250 for the con-
20 struction, alteration, and repair of buildings and improve-
21 ments, but unless otherwise provided the cost of construct-
22 ing any one building shall not exceed \$250,000, except for
23 headhouses or greenhouses which shall each be limited to
24 \$1,000,000, and except for ten buildings to be constructed
25 or improved at a cost not to exceed \$500,000 each, and

1 the cost of altering any one building during the fiscal year
2 shall not exceed 10 percent of the current replacement
3 value of the building or \$250,000, whichever is greater:
4 *Provided further*, That the limitations on alterations con-
5 tained in this Act shall not apply to modernization or re-
6 placement of existing facilities at Beltsville, Maryland:
7 *Provided further*, That the foregoing limitations shall not
8 apply to replacement of buildings needed to carry out the
9 Act of April 24, 1948 (21 U.S.C. 113a): *Provided further*,
10 That funds may be received from any State, other political
11 subdivision, organization, or individual for the purpose of
12 establishing or operating any research facility or research
13 project of the Agricultural Research Service, as authorized
14 by law: *Provided further*, That the item under the heading
15 “AGRICULTURAL RESEARCH SERVICE” in title I of the
16 Agriculture, Rural Development, Food and Drug Adminis-
17 tration, and Related Agencies Appropriations Act, 1996
18 (Public Law 104-37; 109 Stat. 304), is amended by strik-
19 ing the penultimate proviso, relating to conveyance of the
20 Pecan Genetics and Improvement Research Laboratory.

21 None of the funds in the foregoing paragraph shall
22 be available to carry out research related to the produc-
23 tion, processing or marketing of tobacco or tobacco prod-
24 ucts.

1 BUILDINGS AND FACILITIES

2 For acquisition of land, construction, repair, improve-
3 ment, extension, alteration, and purchase of fixed equip-
4 ment or facilities as necessary to carry out the agricultural
5 research programs of the Department of Agriculture,
6 where not otherwise provided, \$59,000,000, to remain
7 available until expended (7 U.S.C. 2209b): *Provided*, That
8 funds may be received from any State, other political sub-
9 division, organization, or individual for the purpose of es-
10 tablishing any research facility of the Agricultural Re-
11 search Service, as authorized by law.

12 COOPERATIVE STATE RESEARCH, EDUCATION, AND
13 EXTENSION SERVICE

14 RESEARCH AND EDUCATION ACTIVITIES

15 For payments to agricultural experiment stations, for
16 cooperative forestry and other research, for facilities, and
17 for other expenses, including \$168,734,000 to carry into
18 effect the provisions of the Hatch Act (7 U.S.C. 361a-
19 361i); \$20,497,000 for grants for cooperative forestry re-
20 search (16 U.S.C. 582a-582a7); \$27,735,000 for pay-
21 ments to the 1890 land-grant colleges, including Tuskegee
22 University (7 U.S.C. 3222); \$32,154,000 for special
23 grants for agricultural research (7 U.S.C. 450i(e));
24 \$17,327,000 for special grants for agricultural research
25 on improved pest control (7 U.S.C. 450i(e));

1 \$106,744,000 for competitive research grants (7 U.S.C.
2 450i(b)); \$4,500,000 for the support of animal health and
3 disease programs (7 U.S.C. 3195); \$650,000 for supple-
4 mental and alternative crops and products (7 U.S.C.
5 3319d); \$500,000 for grants for research pursuant to the
6 Critical Agricultural Materials Act of 1984 (7 U.S.C. 178)

14 Payments to States, the District of Columbia, Puerto
15 Rico, Guam, the Virgin Islands, Micronesia, Northern
16 Marianas, and American Samoa: For payments for coop-

11 State, the District of Columbia, Puerto Rico, Guam, or
12 the Virgin Islands, Micronesia, Northern Marianas, and
13 American Samoa prior to availability of an equal sum from
14 non-Federal sources for expenditure during the current
15 fiscal year.

16 OFFICE OF THE ASSISTANT SECRETARY FOR
17 MARKETING AND REGULATORY PROGRAMS

18 For necessary salaries and expenses of the Office of
19 the Assistant Secretary for Marketing and Regulatory
20 Programs to administer programs under the laws enacted
21 by the Congress for the Animal and Plant Health Inspec-
22 tion Service, the Agricultural Marketing Service, and the
23 Grain Inspection, Packers and Stockyards Administration,
24 \$618,000.

1 ANIMAL AND PLANT HEALTH INSPECTION SERVICE
2 SALARIES AND EXPENSES
3 (INCLUDING TRANSFERS OF FUNDS)

4 For expenses, not otherwise provided for, including
5 those pursuant to the Act of February 28, 1947, as
6 amended (~~21 U.S.C. 114b–114e~~), necessary to prevent,
7 control, and eradicate pests and plant and animal dis-
8 eases; to carry out inspection, quarantine, and regulatory
9 activities; to discharge the authorities of the Secretary of
10 Agriculture under the Act of March 2, 1931 (46 Stat.
11 1468; ~~7 U.S.C. 426–426b~~); and to protect the environ-
12 ment, as authorized by law, \$424,244,000, of which
13 \$4,443,000 shall be available for the control of outbreaks
14 of insects, plant diseases, animal diseases and for control
15 of pest animals and birds to the extent necessary to meet
16 emergency conditions: *Provided*, That no funds shall be
17 used to formulate or administer a brucellosis eradication
18 program for the current fiscal year that does not require
19 minimum matching by the States of at least 40 percent:
20 *Provided further*, That this appropriation shall be available
21 for field employment pursuant to the second sentence of
22 section 706(a) of the Organic Act of 1944 (~~7 U.S.C.~~
23 ~~2225~~), and not to exceed \$40,000 shall be available for
24 employment under ~~5 U.S.C. 3109~~: *Provided further*, That
25 this appropriation shall be available for the operation and

1 maintenance of aircraft and the purchase of not to exceed
2 four, of which two shall be for replacement only: *Provided*
3 *further*, That, in addition, in emergencies which threaten
4 any segment of the agricultural production industry of this
5 country, the Secretary may transfer from other appropria-
6 tions or funds available to the agencies or corporations
7 of the Department such sums as he may deem necessary,
8 to be available only in such emergencies for the arrest and
9 eradication of contagious or infectious disease or pests of
10 animals, poultry, or plants, and for expenses in accordance
11 with the Act of February 28, 1947, as amended, and sec-
12 tion 102 of the Act of September 21, 1944, as amended,
13 and any unexpended balances of funds transferred for
14 such emergency purposes in the next preceding fiscal year
15 shall be merged with such transferred amounts: *Provided*
16 *further*, That appropriations hereunder shall be available
17 pursuant to law (7 U.S.C. 2250) for the repair and alter-
18 ation of leased buildings and improvements, but unless
19 otherwise provided the cost of altering any one building
20 during the fiscal year shall not exceed 10 percent of the
21 current replacement value of the building.

22 In fiscal year 1998 the agency is authorized to collect
23 fees to cover the total costs of providing technical assist-
24 ance, goods, or services requested by States, other political
25 subdivisions, domestic and international organizations,

1 foreign governments, or individuals, provided that such
2 fees are structured such that any entity's liability for such
3 fees is reasonably based on the technical assistance, goods,
4 or services provided to the entity by the agency, and such
5 fees shall be credited to this account, to remain available
6 until expended, without further appropriation, for provid-
7 ing such assistance, goods, or services.

8 Of the total amount available under this heading in
9 fiscal year 1998, \$88,000,000 shall be derived from user
10 fees deposited in the Agricultural Quarantine Inspection
11 User Fee Account.

12 BUILDINGS AND FACILITIES

13 For plans, construction, repair, preventive mainte-
14 nance, environmental support, improvement, extension, al-
15 teration, and purchase of fixed equipment or facilities, as
16 authorized by 7 U.S.C. 2250, and acquisition of land as
17 authorized by 7 U.S.C. 428a, \$3,200,000, to remain avail-
18 able until expended.

19 AGRICULTURAL MARKETING SERVICE

20 MARKETING SERVICES

21 For necessary expenses to carry on services related
22 to consumer protection, agricultural marketing and dis-
23 tribution, transportation, and regulatory programs, as au-
24 thorized by law, and for administration and coordination
25 of payments to States, including field employment pursu-

1 ant to section 706(a) of the Organic Act of 1944 (7 U.S.C.
 2 2225), and not to exceed \$90,000 for employment under
 3 ~~5 U.S.C. 3109, \$45,592,000, including funds for the~~
 4 wholesale market development program for the design and
 5 development of wholesale and farmer market facilities for
 6 the major metropolitan areas of the country: *Provided,*
 7 That this appropriation shall be available pursuant to law
 8 (7 U.S.C. 2250) for the alteration and repair of buildings
 9 and improvements, but the cost of altering any one build-
 10 ing during the fiscal year shall not exceed 10 percent of
 11 the current replacement value of the building.

12 Fees may be collected for the cost of standardization
 13 activities, as established by regulation pursuant to law (31
 14 U.S.C. 9701).

15 LIMITATION ON ADMINISTRATIVE EXPENSES

16 Not to exceed \$59,521,000 (from fees collected) shall
 17 be obligated during the current fiscal year for administra-
 18 tive expenses: *Provided,* That if crop size is understated
 19 and/or other uncontrollable events occur, the agency may
 20 exceed this limitation by up to 10 percent with notification
 21 to the Appropriations Committees.

22 FUNDS FOR STRENGTHENING MARKETS, INCOME, AND
 23 SUPPLY (SECTION 32)
 24 (INCLUDING TRANSFERS OF FUNDS)

25 Funds available under section 32 of the Act of Au-
 26 gust 24, 1935 (7 U.S.C. 612e) shall be used only for com-

1 modify program expenses as authorized therein, and other
2 related operating expenses, except for: (1) transfers to the
3 Department of Commerce as authorized by the Fish and
4 Wildlife Act of August 8, 1956; (2) transfers otherwise
5 provided in this Act; and (3) not more than \$10,690,000
6 for formulation and administration of marketing agree-
7 ments and orders pursuant to the Agricultural Marketing
8 Agreement Act of 1937, as amended, and the Agricultural
9 Act of 1961.

10 PAYMENTS TO STATES AND POSSESSIONS

11 For payments to departments of agriculture, bureaus
12 and departments of markets, and similar agencies for
13 marketing activities under section 204(b) of the Agricul-
14 tural Marketing Act of 1946 (7 U.S.C. 1623(b)),
15 \$1,200,000.

16 GRAIN INSPECTION, PACKERS AND STOCKYARDS

17 ADMINISTRATION

18 SALARIES AND EXPENSES

8 dated Farm and Rural Development Act, \$51,400,000, to
9 remain available until expended, for direct loans and loan
10 guarantees for business and industry assistance and rural
11 business enterprise grants of the Rural Business-Coopera-
12 tive Service: *Provided*, That the cost of direct loans and
13 loan guarantees shall be as defined in section 502 of the
14 Congressional Budget Act of 1974, as amended: *Provided*

5 Insured loans pursuant to the authority of section
6 305 of the Rural Electrification Act of 1936, as amended
7 (7 U.S.C. 935), shall be made as follows: 5 percent rural
8 electrification loans, \$125,000,000; 5 percent rural tele-
9 communications loans, \$75,000,000; cost of money rural

21 and Inspection Service, field automation and information
22 management project; funds appropriated for rental pay-
23 ments; funds for the Native American Institutions Endow-
24 ment Fund in the Cooperative State Research, Education,
25 and Extension Service; and funds for the competitive re-

1 search grants (7 U.S.C. 450i(b)), shall remain available
2 until expended.

3 SEC. 706. No part of any appropriation contained in
4 this Act shall remain available for obligation beyond the
5 current fiscal year unless expressly so provided herein.

6 SEC. 707. Not to exceed \$50,000 of the appropria-
7 tions available to the Department of Agriculture in this
8 Act shall be available to provide appropriate orientation
9 and language training pursuant to Public Law 94-449.

10 SEC. 708. No funds appropriated by this Act may be
11 used to pay negotiated indirect cost rates on cooperative
12 agreements or similar arrangements between the United
13 States Department of Agriculture and nonprofit institu-
14 tions in excess of 10 percent of the total direct cost of
15 the agreement when the purpose of such cooperative ar-
16 rangements is to carry out programs of mutual interest
17 between the two parties. This does not preclude appro-
18 priate payment of indirect costs on grants and contracts
19 with such institutions when such indirect costs are com-
20 puted on a similar basis for all agencies for which appro-
21 priations are provided in this Act.

22 SEC. 709. Notwithstanding any other provision of
23 this Act, commodities acquired by the Department in con-
24 nection with Commodity Credit Corporation and section
25 32 price support operations may be used, as authorized

1 by law (15 U.S.C. 714e and 7 U.S.C. 612e), to provide
2 commodities to individuals in cases of hardship as deter-
3 mined by the Secretary of Agriculture.

4 SEC. 710. None of the funds in this Act shall be avail-
5 able to reimburse the General Services Administration for
6 payment of space rental and related costs in excess of the
7 amounts specified in this Act; nor shall this or any other
8 provision of law require a reduction in the level of rental
9 space or services below that of fiscal year 1997 or prohibit
10 an expansion of rental space or services with the use of
11 funds otherwise appropriated in this Act. Further, no
12 agency of the Department of Agriculture, from funds oth-
13 erwise available, shall reimburse the General Services Ad-
14 ministration for payment of space rental and related costs
15 provided to such agency at a percentage rate which is
16 greater than is available in the case of funds appropriated
17 in this Act.

18 SEC. 711. None of the funds in this Act shall be avail-
19 able to restrict the authority of the Commodity Credit
20 Corporation to lease space for its own use or to lease space
21 on behalf of other agencies of the Department of Agri-
22 culture when such space will be jointly occupied.

23 SEC. 712. With the exception of grants awarded
24 under the Small Business Innovation Development Act of
25 1982, Public Law 97-219, as amended (15 U.S.C. 638),

1 none of the funds in this Act shall be available to pay
2 indirect costs on research grants awarded competitively by
3 the Cooperative State Research, Education, and Extension
4 Service that exceed 14 percent of total Federal funds pro-
5 vided under each award.

6 SEC. 713. Notwithstanding any other provisions of
7 this Act, all loan levels provided of this Act shall be consid-
8 ered estimates, not limitations.

9 SEC. 714. Appropriations to the Department of Agri-
10 culture for the cost of direct and guaranteed loans made
11 available in fiscal year 1998 shall remain available until
12 expended to cover obligations made in fiscal year 1998 for
13 the following accounts: the rural development loan fund
14 program account; the Rural Telephone Bank program ac-
15 count; the rural electrification and telecommunications
16 loans program account; and the rural economic develop-
17 ment loans program account.

18 SEC. 715. Such sums as may be necessary for fiscal
19 year 1998 pay raises for programs funded by this Act shall
20 be absorbed within the levels appropriated in this Act.

21 SEC. 716. (a) COMPLIANCE WITH BUY AMERICAN
22 ACT.—None of the funds made available in this Act may
23 be expended by an entity unless the entity agrees that in
24 expending the funds the entity will comply with sections

1 2 through 4 of the Act of March 3, 1933 (41 U.S.C. 10a-
2 10e; popularly known as the “Buy American Act”).

3 (b) SENSE OF CONGRESS; REQUIREMENT REGARD-
4 ING NOTICE.—

5 (1) PURCHASE OF AMERICAN-MADE EQUIPMENT
6 AND PRODUCTS.—In the case of any equipment or
7 product that may be authorized to be purchased
8 with financial assistance provided using funds made
9 available in this Act, it is the sense of the Congress
10 that entities receiving the assistance should, in ex-
11 pending the assistance, purchase only American-
12 made equipment and products.

13 (2) NOTICE TO RECIPIENTS OF ASSISTANCE.—
14 In providing financial assistance using funds made
15 available in this Act, the head of each Federal agen-
16 cy shall provide to each recipient of the assistance
17 a notice describing the statement made in paragraph
18 (1) by the Congress.

19 (c) PROHIBITION OF CONTRACTS WITH PERSONS
20 FALSELY LABELING PRODUCTS AS MADE IN AMERICA.—
21 If it has been finally determined by a court or Federal
22 agency that any person intentionally affixed a label bear-
23 ing a “Made in America” inscription, or any inscription
24 with the same meaning, to any product sold in or shipped
25 to the United States that is not made in the United

1 States, the person shall be ineligible to receive any con-
2 tract or subcontract made with funds made available in
3 this Act, pursuant to the debarment, suspension, and ineli-
4 gibility procedures described in sections 9.400 through
5 9.409 of title 48, Code of Federal Regulations.

6 SEC. 717. Notwithstanding the Federal Grant and
7 Cooperative Agreement Act, marketing services of the Ag-
8 ricultural Marketing Service and the Animal and Plant
9 Health Inspection Service may use cooperative agreements
10 to reflect a relationship between the Agricultural Market-
11 ing Service or the Animal and Plant Health Inspection
12 Service and a State or Cooperator to carry out agricultural
13 marketing programs or to carry out programs to protect
14 the Nation's animal and plant resources.

15 SEC. 718. None of the funds in this Act may be used
16 to retire more than 5 percent of the Class A stock of the
17 Rural Telephone Bank or to maintain any account or sub-
18 account within the accounting records of the Rural Tele-
19 phone Bank the creation of which has not specifically been
20 authorized by statute: *Provided*, That notwithstanding any
21 other provision of law, none of the funds appropriated or
22 otherwise made available in this Act may be used to trans-
23 fer to the Treasury or to the Federal Financing Bank any
24 unobligated balance of the Rural Telephone Bank tele-
25 phone liquidating account which is in excess of current

1 requirements and such balance shall receive interest as set
2 forth for financial accounts in section 505(e) of the Fed-
3 eral Credit Reform Act of 1990.

4 SEC. 719. None of the funds made available in this
5 Act may be used to provide assistance to, or to pay the
6 salaries of personnel who carry out a market promotion/
7 market access program pursuant to section 203 of the Ag-
8 ricultural Trade Act of 1978 (7 U.S.C. 5623) that pro-
9 vides assistance to the United States Mink Export Devel-
10 opment Council or any mink industry trade association.

11 SEC. 720. Of the funds made available by this Act,
12 not more than \$1,000,000 shall be used to cover necessary
13 expenses of activities related to all advisory committees,
14 panels, commissions, and task forces of the Department
15 of Agriculture except for panels used to comply with nego-
16 tiated rule makings and panels used to evaluate competi-
17 tively awarded grants.

18 SEC. 721. None of the funds appropriated or other-
19 wise made available by this Act shall be used to pay the
20 salaries and expenses of personnel who carry out an export
21 enhancement program if the aggregate amount of funds
22 and/or commodities under such program exceeds
23 \$205,000,000.

24 SEC. 722. No employee of the Department of Agri-
25 culture may be detailed or assigned from an agency or

1 office funded by this Act to any other agency or office
2 of the Department for more than 30 days unless the indi-
3 vidual's employing agency or office is fully reimbursed by
4 the receiving agency or office for the salary and expenses
5 of the employee for the period of assignment.

6 SEC. 723. None of the funds appropriated or other-
7 wise made available to the Department of Agriculture
8 shall be used to transmit or otherwise make available to
9 any non-Department of Agriculture employee questions or
10 responses to questions that are a result of information re-
11 quested for the appropriations hearing process.

12 SEC. 724. None of the funds appropriated or other-
13 wise made available in this Act may be expended or obli-
14 gated to fund the activities of the Western Director and
15 Special Assistant to the Secretary within the Office of the
16 Secretary of Agriculture or any similar position.

17 SEC. 725. None of the funds made available to the
18 Department of Agriculture by this Act may be used to ac-
19 quire new information technology systems or significant
20 upgrades, as determined by the Office of the Chief Infor-
21 mation Officer, without the approval of the Chief Informa-
22 tion Officer and the concurrence of the Executive Informa-
23 tion Technology Investment Review Board.

24 SEC. 726. For an additional amount for the purposes
25 provided for under the heading "DEPARTMENTAL ADMIN-

1 ISTRATION” in title I of this Act, \$1,500,000, and the
2 amount provided under “NATIONAL AGRICULTURAL STA-
3 TISTICS SERVICE” is hereby reduced by \$1,500,000.

4 SEC. 727. None of the funds appropriated or other-
5 wise made available by this Act may be made available
6 to provide assistance to the Democratic People’s Republic
7 of Korea, except for assistance that is provided directly
8 to needy people by the United Nations World Food Pro-
9 gram or private voluntary organizations registered with
10 the United States Agency for International Development,
11 and not by the Government of the Democratic People’s
12 Republic of Korea.

13 SEC. 728. None of the funds made available in title
14 III of this Act may be used to provide any assistance
15 (other than the servicing of loans made on or before Sep-
16 tember 30, 1997) under any program under title V of the
17 Housing Act of 1949 relating to any housing or project
18 located, or to be located, in the City of Galt, California.

12 *ACREAGE.*—None of the funds appropriated in this Act may
13 be used to administer the provision of contract payments
14 to a producer under the Agricultural Market Transition Act
15 (7 U.S.C. 7201 et seq.) for contract acreage on which wild
16 rice is planted unless the contract payment is reduced by
17 an acre for each contract acre planted to wild rice.

18 SEC. 732. *INSPECTION AND CERTIFICATION OF AGRICUL-*
19 *CULTURAL PROCESSING EQUIPMENT. (a) IN GENERAL.*—
20 Except as provided in subsection (b), none of the funds
