A BILL

To abolish the Thrift Depositor Protection Oversight Board,
and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 *This Act may be cited as the “Thrift Depositor Protec-*
3 *tion Oversight Board Abolishment Act”.*

4 **SEC. 2. ABOLISHMENT OF THE THRIFT DEPOSITOR PRO-**
5 **TECTION OVERSIGHT BOARD.**

6 (a) *IN GENERAL.*—*Effective at the end of the 3-month*
7 *period beginning on the date of enactment of this Act, the*
8 *Thrift Depositor Protection Oversight Board established*
9 *under section 21A of the Federal Home Loan Bank Act*
10 *(hereafter in this section referred to as the “Oversight*
11 *Board”)* *is hereby abolished.*

12 (b) *DISPOSITION OF AFFAIRS.*—

13 (1) *POWER OF CHAIRPERSON.*—*Effective on the*
14 *date of the enactment of this Act, the Chairperson of*
15 *the Oversight Board (or the designee of the Chair-*
16 *person) may exercise on behalf of the Oversight Board*
17 *any power of the Oversight Board necessary to settle*
18 *and conclude the affairs of the Oversight Board.*

19 (2) *AVAILABILITY OF FUNDS.*—*Funds available*
20 *to the Oversight Board shall be available to the Chair-*
21 *person of the Oversight Board to pay expenses in-*
22 *curring in carrying out the requirements of paragraph*
23 *(1).*

24 (c) *SAVINGS PROVISION.*—

25 (1) *EXISTING RIGHTS, DUTIES, AND OBLIGA-*
26 *TIONS NOT AFFECTED.*—*No provision of this Act shall*

1 *be construed as affecting the validity of any right,*
2 *duty, or obligation of the United States, the Oversight*
3 *Board, the Resolution Trust Corporation, or any*
4 *other person which—*

5 *(A) arises under or pursuant to the Federal*
6 *Home Loan Bank Act, or any other provision of*
7 *law applicable with respect to the Oversight*
8 *Board; and*

9 *(B) existed on the day before the abolish-*
10 *ment of the Oversight Board in accordance with*
11 *subsection (a).*

12 *(2) CONTINUATION OF SUITS.—No action or*
13 *other proceeding commenced by or against the Over-*
14 *sight Board with respect to any function of the Over-*
15 *sight Board shall abate by reason of the enactment of*
16 *this Act.*

17 *(3) LIABILITIES.—*

18 *(A) IN GENERAL.—All liabilities arising out*
19 *of the operation of the Oversight Board between*
20 *August 9, 1989, and the end of the 3-month pe-*
21 *riod beginning on the date of enactment of this*
22 *Act shall remain the direct liabilities of the*
23 *United States.*

24 *(B) NO SUBSTITUTION.—The Secretary of*
25 *the Treasury shall not be substituted for the*

1 *Oversight Board as a party to any such action*
2 *or proceeding.*

3 (4) *CONTINUATIONS OF ORDERS, RESOLUTIONS,*
4 *DETERMINATIONS, AND REGULATIONS PERTAINING TO*
5 *THE RESOLUTION FUNDING CORPORATION.—*

6 (A) *IN GENERAL.—All orders, resolutions,*
7 *determinations, and regulations regarding the*
8 *Resolution Funding Corporation which—*

9 (i) *have been issued, made, and pre-*
10 *scribed, or allowed to become effective by the*
11 *Oversight Board, or by a court of competent*
12 *jurisdiction, in the performance of functions*
13 *which are transferred by this Act; and*

14 (ii) *are in effect at the end of the 3-*
15 *month period beginning on the date of the*
16 *enactment of this Act,*

17 *shall continue in effect according to the terms of*
18 *such orders, resolutions, determinations, and reg-*
19 *ulations until modified, terminated, set aside, or*
20 *superseded in accordance with applicable law.*

21 (B) *ENFORCEABILITY OF ORDERS, RESOLU-*
22 *TIONS, DETERMINATIONS, AND REGULATIONS BE-*
23 *FORE TRANSFER.—Before the effective date of the*
24 *transfer of the authority and duties of the Reso-*
25 *lution Funding Corporation to the Secretary of*

1 *the Treasury under section 3, all orders, resolu-*
2 *tions, determinations, and regulations pertain-*
3 *ing to the Resolution Funding Corporation shall*
4 *be enforceable by and against the United States.*

5 (C) *ENFORCEABILITY OF ORDERS, RESOLU-*
6 *TIONS, DETERMINATIONS, AND REGULATIONS*
7 *AFTER TRANSFER.—On and after the effective*
8 *date of the transfer of the authority and duties*
9 *of the Resolution Funding Corporation to the*
10 *Secretary of the Treasury, all orders, resolutions,*
11 *determinations, and regulations pertaining to*
12 *the Resolution Funding Corporation shall be en-*
13 *forceable by and against the Secretary of the*
14 *Treasury.*

15 **SEC. 3. TRANSFER OF THRIFT DEPOSITOR PROTECTION**
16 **OVERSIGHT BOARD AUTHORITY AND DUTIES**
17 **OF RESOLUTION FUNDING CORPORATION TO**
18 **THE SECRETARY OF THE TREASURY.**

19 *The authority and duties of the Thrift Depositor Pro-*
20 *tection Oversight Board under sections 21A(a)(6)(I) and*
21 *21B of the Federal Home Loan Bank Act are hereby trans-*
22 *ferred to the Secretary of the Treasury (or the designee of*
23 *the Secretary) as of the end of the 3-month period beginning*
24 *on the date of enactment of this Act.*

1 **SEC. 4. MEMBERSHIP OF THE AFFORDABLE HOUSING ADVI-**
 2 **SORY BOARD.**

3 *Effective on the date of enactment of this Act, section*
 4 *14(b)(2) of the Resolution Trust Corporation Completion*
 5 *Act (12 U.S.C. 1831q note) is amended—*

6 *(1) by striking subparagraph (C); and*

7 *(2) by redesignating subparagraphs (D) and (E)*
 8 *as subparagraphs (C) and (D), respectively.*

9 **SEC. 5. TIME OF MEETINGS OF THE AFFORDABLE HOUSING**
 10 **ADVISORY BOARD.**

11 *(a) IN GENERAL.—Section 14(b)(6)(A) of the Resolu-*
 12 *tion Trust Corporation Completion Act (12 U.S.C. 1831q*
 13 *note) is amended—*

14 *(1) by striking “4 times a year, or more fre-*
 15 *quently if requested by the Thrift Depositor Protection*
 16 *Oversight Board or” and inserting “2 times a year or*
 17 *at the request of”; and*

18 *(2) by striking the 2d sentence.*

19 *(b) CLERICAL AMENDMENT.—The heading for section*
 20 *14(b)(6)(A) of the Resolution Trust Corporation Completion*
 21 *Act (12 U.S.C. 1831q note) is amended by striking “AND*
 22 *LOCATION”.*
